33 Mr. Ben Mastrianni discussed with the Committee the amount of volume and speed that

- Wyoming Ave endures every day. He asked for input from the Committee on what actions could
- be taken. Mr. Mastrianni asked Ms. Robertson if Wyoming Ave could drop its speed limit to 20
- 36 mph. Ms. Robertson stated the Town would need permission from the State for this to happen.
- 37 Mr. Levy added that there has been a big push to allow cities and towns to regulate their own
- speed limits. As of today, it hasn't happened. He stated that he liked Ms. Robertson's idea of
- using Wyoming as a speed demonstration project. Ms. Manzo agreed. She stated that Wyoming
- 40 is a wider street than Regent and could support a demonstration.
- 41 Mr. Mastrianni asked the Committee who controls how MapQuest or Google Maps send people
- 42 for directions. Ms. Robertson stated she has reached out to Google on routing before and
- 43 received no response.
- Chairman Chapman thanked Mr. Mastrianni for attending the meeting and stated the committee
- will get to work on how they can help.

### 46 2. Fieldstone Drive speed issue

- 47 Ms. Robertson stated she was contacted by the Police Department to look into traffic calming
- 48 measures for Fieldstone Drive. She stated that there is a stretch of Road that connects Fieldstone
- 49 to State Street and it is being used for a cut through from State to Consaul. The Police study
- showed an uptick of speed in this area. The committee discussed options for traffic calming in
- 51 this area. This included bump outs and medians.

### 4. Paul Brownsey – Rosendale Road and Old River Road Intersection Improvement

- 53 Mr. Brownsey discussed with the Committee the upcoming County project regarding that
- 54 intersection. He displayed the options presented by the County. He stated that a change needs to
- 55 happen but he is concerned with the options presented. Mr. Brownsey discussed all three
- options. One of Mr. Brownsey's concerns related to there being no options for cyclists or
- 57 pedestrians. He stated that people do use the road to walk and bike on and this should be
- 58 considered.

- Ms. Robertson stated she has not been in contact with the County on this and that due to this
- 60 being a County Road, the Town does not control the approval process. She added that though
- Niskayuna does not have a formal role they can reach out and give suggestions to the County.
- Ms. Robertson asked for input from other Committee members.

- 73 Craig Elementary and Troy/Schenectady Road. Chairman Chapman stated similar letters with
- 74 the top 3 priorities will be sent to State, County and District. The Committee discussed the
- 75 importance of being concise with each request. Ms. Manzo emphasized the need to be clear on
- 76 what is requested with each letter. This will help achieve each goal so that it does not get lost in
- 77 the pile of other needs.

### 2. Complete Streets Survey Results (Mr. Levy)

- 79 Chairman Chapman stated the Committee received about 365 responses to the survey. Mr. Levy
- stated that the response to the survey was incredible. It had 100% completion which is amazing
- 81 for a survey that takes approximately 9 minutes to complete. Mr. Levy stated that the majority
- of responses were in the first few days.
- 83 Mr. Levy gave a brief overview of the survey. He stated that residents are walking
- 84 approximately 3-5 days or more a week. They do not feel the safety has changed since the
- 85 pandemic.

### A RESOLUTION ADOPTING COMPLETE STREETS PRIORITY LETTERS FOR THE TOWN, COUNTY, STATE AND SCHOOLS WITHIN THE TOWN OF NISKAYUNA

The following resolution was offered by Councilman Della Ratta and Councilwoman McGraw, who moved its adoption, and seconded by

BE IT ENACTED, by the Town Board of the Town of Niskayuna, as follows:

WHEREAS, by Resolution No. 2016-158, the Town Board established a Complete Streets Committee for the Town of Niskayuna to study areas of the Town where Complete Streets could be implemented and advise as to best practices for such implementation; and

WHEREAS, by Resolution No. 2017-41, the Town Board established a Complete Streets Policy with the intent to give bicyclists, pedestrians, motorists and mass transit equal consideration in the planning and design of all new street construction and street reconstruction undertaken by the Town; and

WHEREAS, the Complete Streets Policy states the Town's intent to recognize that principal Town roads that are characterized as having high vehicle volumes and high travel speeds are important for bicycle and pedestrian travel to access and connect to destinations in and adjacent to the Town and shall be considered for Complete Streets treatments; and

WHEREAS, the Complete Streets Policy further encourages NYSDOT and Schenectady County to consider Complete Streets approaches to their respective streets in the Town of Niskayuna; and

WHEREAS, in furtherance of the Complete Streets Policy goals, the Complete Streets Committee has developed priority letters identifying their top three recommended Complete Street treatments that could be undertaken within Niskayuna by the Town, County, State and Niskayuna schools; and

WHEREAS, the Economic Development, Historic Preservation and Environmental Conservation Committee, the Water, Sewer and Engineering Committee, and the Highway, Parks and Recreation Committee concurs with their priority letter recommendations.

NOW, THEREFORE, be it

RESOLVED, that this Town Board does hereby endorse the attached Complete Streets priority letters and authorize the Town Supervisor to execute said letters in support and furtherance of the Town of Niskayuna's Complete Streets Policy.

The Town of Niskayuna appointed a Complete Streets Committee and adopted a Complete Streets Policy to enable safe and convenient access to our streets for all users and support and invite safe, active and ample space for pedestrians, bicycle and public transportation. This in turn promotes healthy living, cost savings, reduces traffic congestion and helps lower greenhouse gas emissions, improving the general quality of life to New York residents.

One of the tasks for the Complete Streets Committee is to work with Schenectady County on Complete Streets initiatives in the Town of Niskayuna. We have been reviewing priorities and have identified the following top three priorities for implementation in Niskayuna.

### 1. Crosswalk at Nott Street and Regent Street

The Complete Streets Committee identified this as the best location for school aged children and pedestrians to cross Nott Street. Schools and businesses south of Nott Street are a large draw for pedestrians in the northern neighborhoods. Creating a high visibility crosswalk at this location will increase safety and encourage people to cross Nott St in a single spot. The Town is currently pursing funding this with a grant.

### 2. Crosswalk at St. Joseph's Drive and River Road

St. Joseph's Drive and River Road is a high traffic pedestrian and bicycle crossing of River Road because St. Joseph's is at the end of a signed on-road bike path "Canalway Trail" that connects to the Mohawk Hudson Bike Hike Trail (MHBHT) across River Road. The "Canalway Trail" bike route also connects into the Nott St East bike path and Windsor Estates, so this trail connects a lot of neighborhoods and funnels them to cross at River Road if they are going north. The Town is currently pursing funding this with a grant.

### 3. Crosswalks and sidewalks on Rosendale Road to Lisha Kill

Currently a sidewalk goes from Mayfair Road to Rosehill Boulevard along Rosendale Road. It is a heavily used sidewalk and critical pedestrian connection for the Rosendale Estates subdivisions to access schools and churches. The Complete Streets Committee has identified the need for a multi-use path / sidewalk to extend from Rosehill Boulevard to Iroquois Middle and Rosendale Elementary schools. The addition of these sidewalks and crosswalks will encourage safe pedestrian traffic to the schools and reduce the need for vehicle trips on Rosendale Road.

We understand that budget constraints, staff time and prior commitments all have a role to play, but we'd like to discuss these priorities with you to move them forward in 2021. We will be contacting your

The Town of Niskayuna appointed a Complete Streets Committee and adopted a Complete Streets Policy to enable safe and convenient access to our streets for all users and support and invite safe, active and ample space for pedestrians, bicycle and public transportation. This in turn promotes healthy living, cost savings, reduces traffic congestion and helps lower greenhouse gas emissions, improving the general quality of life to New York residents.

One of the tasks for the Complete Streets Committee is to work with the Niskayuna Central School System on Complete Streets initiatives in the Town of Niskayuna. We have been reviewing priorities and have identified the following top three priorities for implementation in Niskayuna.

### 1. School Zone for Craig Elementary School

The Town of Niskayuna received a grant award from the Capital District Transportation Committee/Capital District Regional Planning Committee (CDTC/CDRPC) for technical assistance to evaluate potential improvements to the walking environment along Balltown Road in the vicinity of the Craig Elementary School. The first and most crucial step for Complete Streets improvements for all modes of traffic in that area is to establish a school zone in front of Craig Elementary School.

### 2. Crosswalk for Craig Elementary School and Schenectady JCC

The second critical step for Complete Streets identified in the CDTC/CDRPC study is the creation of a crosswalk between Craig Elementary School and the Schenectady JCC. Many Craig Elementary School students attend after school programs at the JCC, there is an overlap in staff and the JCC is the shelter in place site for the school. Aerial photography indicates there was a crosswalk between the two as little as 8 years ago, and the lack of crosswalk there now creates difficulty for these two major pedestrian generators.

### 3. Paving trails connecting River Road Park to Rosendale & Iroquois schools

Many students and pedestrians who live in the Rosendale Estates subdivisions use rudimentary trails that run through River Road Park to access the neighborhood schools. Paving trails from the two school buildings to the school property line with River Road Park will make them more user friendly and increase their usage. Increased pedestrian/bicycle traffic will decrease vehicular traffic and greenhouse emissions and improve drop off and pick-up times for schools.

We understand that budget constraints, staff time and prior commitments all have a role to play, but we'd like to discuss these priorities with you to move them forward in 2021. Many Craig Elementary School students attend after school programs at the JCC, there is an overlap in staff and the JCC is the shelter in place site for the school. Aerial photography indicates there was a crosswalk between the two as little as 8 years ago, and the lack of crosswalk there now creates difficulty for these two major pedestrian generators.

### 3. Pedestrian connection to Mohawk Hudson Bike Hike Trail (MHBHT)

Within the last 2 years the Town finished a Transportation Improvement Project that resulted in a pedestrian connection from Flower Hill to the MHBHT. This allows people to access the trail without having to drive to it. A well placed crosswalk across Route 7 will allow more people on the south side of Route 7 to take advantage of this critical pedestrian connection and increase the benefits of this funding.

The Town of Niskayuna appointed a Complete Streets Committee and adopted a Complete Streets Policy to enable safe and convenient access to our streets for all users and support and invite safe, active and ample space for pedestrians, bicycle and public transportation. This in turn promotes healthly living, cost savings, reduces traffic congestion and helps lower greenhouse gas emissions, improving the general quality of life to New Your residents.

One of the tasks for the Complete Streets Committee is to work with Town of Niskayuna on Complete Streets initiatives in the Town of Niskayuna. We have been reviewing priorities and have identified the following top three priorities for implementation in Niskayuna.

### 1. Sidewalk on Plum Street

There is currently a sidewalk on Van Antwerp Road but there is no sidewalk on the block of Plum Street that connects Van Antwerp Road to Hillside Elementary School. This is a heavily traveled pedestrian and vehicle route to the school. The addition of a sidewalk along this section of Plum Street will separate the pedestrian traffic from the vehicular traffic. This will increase safety at a very congested confluence of buses, cars and pedestrians. Additional, the Complete Streets Committee has learned that the most affected property may be willing to work with the Town on this. Because it is a small section of sidewalk, has high safety impacts, and has a property owner willing to work with the Town, this is the Complete Street's Committee's number one priority for 2021.

### 2. Sidewalk on Cornelius Street

Many elementary school children and families use Cornelius Street when walking to Hillside Elementary School. However, the sidewalk on Cornelius Street currently ends at Ray Street. This requires that people walk in the street where cars and buses are traveling to drop off and pick up children. A sidewalk would make the trip safer by separating pedestrian and vehicular traffic, reduce congestion, encourage more people to walk to the school rather than drive, and reduce greenhouse gas emissions.

### 3. Sidewalk on Birchwood to Route 7

There is currently no sidewalk on Birchwood Lane making it difficult for pedestrians and bicycles to safely travel to Birchwood Elementary School. Birchwood is a busy road and walkers need the extra protection on this route to make it safely to the school.





## Q2 Thinking about the period prior to the Pandemic (prior to February 2020), how many days a week would you say you were walking or biking in Niskayuna?





### Q3 During the Pandemic (March 2020 to the present), how many days a week would you say you were walking or biking in Niskayuna?





## Q4 Does it seem like vehicle drivers are more prepared to encounter bicyclists and pedestrians on the street today than they were prior to the pandemic?





## Q5 How often do you experience aggressive drivers as a bicyclist or pedestrian?





## Q6 How safe, from a traffic safety perspective only, do you feel when walking or biking throughout the Town today?







### **Traffic Calming Definitions & Examples**

### Chicane

### **Description:**

A series of alternating curves or lane shifts that force a motorist to steer back and forth instead of traveling a straight path.

### **Roundabout**

### **Description:**

A road junction at which traffic moves in one direction around a central island to reach one of the roads converging on it; a traffic circle.

### **Speed Cushion**

### **Description:**

A median is the portion of the roadway separating opposing directions of the roadway, or local lanes from through travel lanes.

### **Speed Hump**

### **Description:**

Speed humps are 3–4 inches high and 12–14 feet wide, with a ramp length of 3–6 feet, depending on target speed.

Speed humps reduce speeds to 15–20 mph and are often referred to as "bumps" on signage and by the general public.

### **Speed Table**

### **Description:**

Speed tables are mid-block traffic calming devices that raise the entire wheelbase of a vehicle to reduce its traffic speed. Speed tables are longer than speed humps and flat-topped, with a height of 3–3.5 inches and a length of 22 feet.

### **Speed Cushion**

### **Description:**

Speed cushions are either speed humps or speed tables that include wheel cutouts to allow large vehicles to pass unaffected, while reducing passenger car speeds. They can be offset to allow unimpeded passage by emergency vehicles and are typically used on key emergency response routes.
