Minutes – November 3<sup>rd</sup> and November 5<sup>th</sup>, 2021

The Electoral Board of Amelia County met on Wednesday, November 3<sup>rd</sup>, 2021 in the open space behind the Registrar's office. The meeting was called to order by Chairman Williams at 10:12 A.M.

First order of business was to review the provisional ballots. We reviewed a total of ten (10) provisional ballots. Four ballots (4) were counted, five (5) ballots were not counted and one ballot was pending ID verification by 12 noon of Friday, November 5<sup>th</sup>.

Materials from each precinct were reviewed. Precinct #1 reported 741 votes cast, Precinct #2-860. Precinct #3 – 796, Precinct #4 – 713, Precinct #5-1,015. Early voting-1,971 and Absence Voting-258 for a total of **6,354** votes cast.

The meeting was recessed at 12:45 P.M. and will reconvene on Friday, November 5<sup>th</sup> at 3:00 P.M.

**Friday, November 5<sup>th</sup> – 3:00 P.M.**

The Electoral Board of Amelia County reconvened on November 5<sup>th</sup> in the open space behind the Registrar's office. The meeting was called to order by Chairman Williams at 3:01 P.M.

The provisional ballot that was pending ID verification was not counted, voter did not show up. Two uncured ballots were not cured because voters did not show up, subsequently entered on the rejected log.

We opened and reviewed nine ((9) ballots that were post marked before 11/2/21 but received from the post office after the election. There was a **65%** voter turnover for this election. The winners for each office has been determined and made official. Voter credit has been completed per Department of Elections requirements.

Minutes of the October 13<sup>th</sup> meeting was approved as presented.

Questions were raised regarding the List of Officers of Elections and party affiliation. This will be an agenda item for the next meeting.

Hathorn will be out of the office the week of November 20-24; the office will be closed Thursday and Friday for the Thanksgiving holidays.

The next board meeting is scheduled for Tuesday, November 30<sup>th</sup> at 10:-00 A.M.

There being no further business, the meeting was adjourned at 4:25 P.M.
