Section 1— Title, Purpose, Authority

- A. This ordinance shall be known as the Ordinance Establishing the Schedule for Appeals to the Board of Equalization of Real Property Tax Assessments Made During the 2017 General Reassessment.
- B. Pursuant to Section 58.1-3378 of the Code of Virginia, 1950, as amended, the Board of Supervisors of Amelia County hereby sets the deadline dates for the orderly and efficient processing of equalization of real estate assessment to be effective for the 2018 tax year.

Section 2 — Deadlines

- A. The deadline for filing of appeals to the Amelia County Board of Equalization shall be June 15, 2018.
- B. The deadline for disposition of such appeals by the Board of Equalization shall be August 17, 2018.

Section 3 — Effective Dates

- A. This ordinance was duly considered, following a required public hearing held on May 16, 2018, and was adopted by the Board of Supervisors at its regular meeting held on that date and shall be effective upon adoption.



- B. The deadline for disposition of such appeals by the Board of Equalization shall be March 31, 2012.

- A. This ordinance was duly considered, following a required public hearing held on December 21, 2011, and was adopted by the Board of Supervisors at its regular meeting held on that date and shall be effective upon adoption.
