Pickleball and Tennis Court Membership requirements:

- Membership is available for \$3/week, \$10/month, or \$30/year paid in full at the time of application/renewal. Payment can be made at the Parks and Recreation Center or at the adjacent ACPR Concessions when available. Membership begins in the calendar month during which the membership was paid. Renewable.
- Made on written form with one (1) form of photo ID.

PICKLEBALL AND TENNIS COURT MEMBERSHIP AGREEMENT

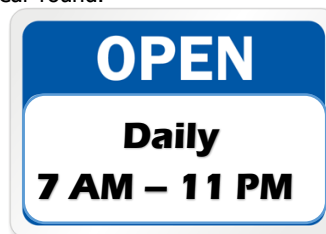
Pickleball and Tennis Court Policy:

- **Location** for the Amelia County Pickleball and Tennis Court ("Court") is located within Joe H. Paulette Memorial Park ("Park"), 16451 Five Forks Road, Amelia, VA. Membership and rules apply to this location only, regulated by Amelia County Parks and Recreation (ACPR).
- **General Policy.** Pickleball and Tennis Courts only may be used for the sport for which they were designed by paying Members. Members must adhere to the rules and regulations of the Park.
- **Footwear.** Only proper tennis athletic footwear can be used in the court area.
- **Minors.** Minors under age 15 must be accompanied by an adult.

ADULT SUPERVISION IS REQUIRED

- **Equipment.** The County provides *nets* for the court. Pickleball nets, *paddles* and *balls* are available at the ACPR Center during business hours at no additional fee, and at ACPR Concessions when available. Equipment must be returned to the ACPR Center immediately following use. Tennis racquets, tennis balls and other equipment are not provided.
- **Usage.** Member must be present during Court use. Only the member and accompanying parties using the Court are permitted in the court area during usage.

- **Usage Preferences to ACPR/ACSD Programs.** Use is on a first come, first serve basis. *Please limit use to 60 minutes when others are waiting.* ACPR and Amelia County School District (ACSD) programs have preferential use of the courts.
- **ACPR Pickleball Organized Play Program.** Courts are reserved for the ACPR Pickleball program every Tuesday and Thursday from 12 noon to 3 pm. This program costs \$1 per person each play day, and is open play, no registration required. Program fee not included in membership.
- **Blackout Dates** The use of the Court will not be permitted during full-park events including the Amelia County Fair held annually in September. (Refer to www.ameliacountyfair.com for dates and information.)
- **Hours.** The Court is open for use daily (seven days a week) from 7 am to 11 pm year-round.



- **Lighting.** Court lighting is available by push button at the light pole *outside the court*. Following use, member is responsible to turn the lights off after use when leaving the Court. NOTE: Failure to turn lights off after use will be considered a violation.
- **Public Restroom** facilities are available seasonally at two park locations during Pickleball and Tennis Court usage. **(1)** In the *food concession area* adjacent to the Court, Parks and Recreation restrooms typically are open April through November during athletic ACPR and Amelia County School District (ACSD) practices and events scheduled evenings and weekends. **(2)** Amelia County restrooms also are available in the *building near the parking area for the County Lot and Joe Paulette Softball Fields* located across from the Court. No schedule of availability has been provided.
- **Parking.** Please park in the loop behind the Court when there are no other events being held in the Park. Please refrain from parking on the grass at the Court entrance. Parking in the Joe Paulette Park overflow parking area is required when gated events are conducted in the park. During these events, please park in these areas as directed and walk down to the Courts. Provisions will be made for handicapped parking.

Court Care. Member is responsible to keep the Court clean and in proper condition during and following use. Trash and Recycle receptacles are available in the surrounding area. **Any damage or concerns to the property must be reported immediately to Parks and Recreation. Phone (804) 561-4100 during Business hours Monday thru Friday 7 am-5 pm. After hours Emergency (804) 314-9073.**

Prohibited Activities and Items:

- **Tournaments** can only be conducted when approved by the ACPR Director. Please contact the ACPR Office to discuss these arrangements.
- **Skateboarding, remote-control devices of any type, hoverboard, heelys, skates of any type** are prohibited from the court area.
- **Wheeled, marking shoes, cleats or sharp objects** are prohibited in the court area.
- **Pets** are not allowed in the court area. Complying with park rules, pets shall always be kept on a leash. Do pickup your pet's waste and properly dispose of it in the receptacles provided. Do not allow your pet to be aggressive towards other persons or pets.
- **Alcoholic beverages** ARE NOT permitted in the parks, leased facilities, or parking lots.
- **Smoking** is not permitted within the Court or field areas.
- **No Loud Music** in accordance with County ordinances.

Violations:

- If there is a violation to these policies for *sharing the access to the Court*, Membership will be revoked for no less than one (1) year and the fee will not be refunded. *Other violations* will be evaluated on a case-by-case basis. Consequences for each violation will be determined by the ACPR Director.

Disclaimer:

- ACPR reserves the right to cancel a membership at any time. Any Member found to be in violation of the policy stated will be subject to

loss of membership and may be grounds for prohibiting future use of ACPR facilities.

- Member agrees to indemnify and hold harmless the County, its agents, and employees from and against any claims for damages to persons or property arising out of any use of the Court and its premises by Member. The Member does hereby assume all liability and responsibility for bodily injuries, claims, or suits for damages to persons or property of whatsoever kind or character, whether real or asserted, occurring in connection with the use of the Court or its premises by Member, his or its agents, servants, employees, contractors or subcontractors. The County assumes no responsibility for any property placed in or about the Court.
