
Report Overview

This document shows the activity of candidates who have pulled or filed petitions with the Board of Elections. Candidates are not required to pull petitions from the Board of Elections, therefore “(P) Not pulled” may appear by some of the listed candidates, otherwise the date the candidate pulled their petitions will be displayed (ex. (P) 01-01-2026). If a candidate has not yet filed their petitions, “(F) Not filed” will appear by their name. Once a candidate files their petitions, the date will be displayed (ex. (F) 01-02-2026). If a candidate’s petitions have not been certified to the ballot, “(C) Not certified” will appear by their name. Once a candidate is certified by the Board, the date will be displayed (ex. (c) 01-03-2026). Candidates and issues for districts that overlap with surrounding counties may be required to file their petitions with another county board of elections, in this case the name of the other county will appear by their name.
