

TRASH COLLECTION

HOUSEHOLD TRASH is collected one day per week. Please place all trash at the curb by 6 A.M. Household cleanouts must be removed by the homeowner. Construction debris must be removed by the homeowner or the contractor.

PREPARATION All trash should be placed in a regular outdoor trash can not to exceed 32 gallons and weigh no more than 50 lbs. or in a trash bag not to exceed 30 lbs.

HYPODERMIC NEEDLES This includes all needles used for home health care. Place all used needles in a needle container. If you do not have one, you may use a plastic bottle or a steel can with a lid that seals or can be taped shut. Label the container so the trash men know there are needles in the container.

MISC. Do not spray bleach or other chemicals on your trash. Make sure all wood items do not exceed four feet in length and have the nails removed or bent over completely. Do not park any vehicles in front of your trash and do not block the entrances to the alleys. Water based paint needs to be dried out with the lid off and placed at the curb on trash day. Household batteries can go in your regular trash.

RECYCLING INFORMATION

RECYCLABLES are collected one day per week with your scheduled trash pick up alternating comingled items and cardboard and paper (see collection calendar). Do NOT use recycling containers for regular trash.



PLACEMENT Leave a space between regular trash containers and recycle containers.

PAPER AND CARDBOARD All uncontaminated corrugated boxes, paper bags, newspapers, junk mail, cereal boxes, office paper, magazines, and books should be flattened and tied in a bundle or placed in a paper bag, box, or a recycle container. DO NOT USE PLASTIC BAGS. Milk cartons, juice boxes, used paper plates, napkins, tissues, toilet paper, and waxed or treated paper CANNOT be recycled.

ACCEPTABLE GLASS All bottles, jars, and jugs including colored glass from food, beverage, or medicine containers should be emptied and rinsed. Labels and rings may be left on.

NOT ACCEPTABLE Cookware, drinking glasses, light bulbs, head lamps, ceramics, windows, mirrors, and safety glass are to be placed in your regular trash.

ACCEPTABLE CANS All aluminum, steel, and bi-metal beverage or food containers and clean foil. This also includes pet food containers.

NOT ACCEPTABLE Containers having paint, solvents, thinners, cleaning chemicals or any other chemical. Place empty container in regular trash. Containers with materials

in them should be held for Salem County Hazardous Waste Day. Call 856-935-7900 for dates and locations.

ACCEPTABLE PLASTICS Symbols or numbers may be found on the bottom of containers. Symbols with numbers 1 and 2 are acceptable. Containers must be emptied and rinsed. Labels and rings may be left on.

NOT ACCEPTABLE Symbols or numbers may be found on the bottom of containers. Symbols with a 3, 4, 5, 6, or 7 are not acceptable and include plastic bags, toys, pools, coolers, trays, tubs, packaging wrap, packing peanuts, styrofoam, and plastic encased items. These items can be placed in your regular trash.

BULK ITEMS

Place bulk items at the curb on your regular scheduled trash day. A label must be purchased in advance of pick up at the Carneys Point Township Municipal Building in the Clerks office located at 303 Harding Highway in accordance with Carneys Point Township Ordinance #746 and affixed to bulk item. If your trash is picked up in an alley put your bulk item at the curb in front of your house.

MOTOR OIL, COOKING OIL, AND ANTIFREEZE must be taken to the Carneys Point Public Works Department located at 344 Penns Grove Auburn Road. The containers must be no less than 1 gallon and no larger than 5 gallons. The hours for drop off are 8:00 A.M. to 2:00 P.M. daily, Monday-Friday.



Misc. Barbecue grills must have charcoal removed. Lawnmowers must be emptied of all gas, oil, and have the wheels removed.

TREE TRIMMINGS AND BRANCHES

Branch Pick Up Will Be Suspended November Through February

PREPARATION Tree branches must be stacked neatly in low piles with the cut ends facing the street. Branches should be no longer than four feet. Logs should be placed in a separate pile and may not be picked up at the same time. Please call for a branch pick-up. If calling after hours, please leave your name, address, and address. <u>WE ARE NO LONGER ACCEPTING BRANCHES ONSITE.</u>

NO BAMBOO WILL BE COLLECTED!

If you hire a contractor to trim or cut down a tree, they are responsible for removing the branches.

GRASS CLIPPINGS Grass clippings must be bagged and weigh no more than 30 lbs.

NO PILE OF YARD TRIMMINGS LARGER THAN 4 CUBIC YARDS WILL BE PICKED UP

(12' long x 4' high, x 4' wide)

LEAVES

During the months of November and December the public works will vacuum leaves that are raked to the curb. DO NOT RAKE OR BLOW THE LEAVES INTO THE STREET FOR THIS WILL CAUSE DRAINAGE ISSUES WHEN IT RAINS. Please do not mix trash or branches with the leaves. You do not have to call when your leaves are bagged or raked to the curb.

Bagged leaves will be picked up through January. The bags are cut and dumped in a truck and stored until spring and the leaves are spread on a field and plowed under.

ELECTRONIC RECYCLING

All electronics will be collected separately with the appropriate sticker. These items include TVs, Stereos, Computers, Monitors, and other electronic items. Please place separate from trash. These items will be collected on your regular trash day.

FLUORESCENT LIGHT BULBS

Please call to schedule a pickup for fluorescent light bulbs as these need to be collected separately and not placed in regular trash.

DO NOT PLACE RECHARGABLE BATTERIES IN TRASH!

Rechargeable Lithium Ion batteries are to be disposed of at Home Depot or Lowes.

CONCRETE

Please call to schedule a pickup.

MUNICIPAL RECYCLING ENFORCEMENT

The municipal enforcement program for recycling is enforced

by Carneys Point Township in conformance with our mandatory recycling ordinance and the Salem County Recycling Plan.

The Carneys Point Municipal Enforcement Inspector is required to make at a minimum, two inspections per month. In addition, he may issue warnings and fines for the violation of the recycling ordinance, provided that such fine does not exceed penalty schedules provided in N.J.A.C. 7:26-5.1 et seg. or under the County Environmental Health Act (CEHA).

Solid waste facilities are not permitted to accept designated recyclable materials commingled with solid waste. The Salem County Improvement Authority will be monitoring the enforcement program and the Salem County Solid Waste Facility which includes inspections of loads prior to placement in the landfill.

STREET OBSTRUCTION 152-33 **OBSTRUCTION OF STREETS** WITH MATERIALS (AMENDED 5-20-1985 BY Ord. No. 393)

No person shall unnecessarily obstruct any street, alley, or public place within the limits of the township with any kind of vehicle or with boxes, lumber, wood, or any other thing.

Other items include basketball nets, soccer goals, etc. as these items impede trash and recycle collection, snow removal, and leaf collection.



From The Office Of The Tax Assessor

Tax Assessor Hours – Monday evenings 5:30-8:00

Commencing on or before July 1, Carneys Point Township will engage the services of a Revaluation firm to conduct physical inspections of all real property within the municipality. The assessor's office seeks updated and accurate data through the inspection process for fair and uniform assessments. The updated property values will be implemented for Tax Year 2025.

The New Jersey State Constitution at Article VII, Section 1, Paragraph 1 requires all real property must be assessed for taxation purposes at the same standard of value. New Jersey statute N.J.S.A. 54:4-2.25 defines the standard as the true value of the full and fair market value of the property.

WHY DO WE NEED A REVALUATION?

Assessments are generally set in one year and then carried over for subsequent tax years. When the housing market changes in later years, your property's static assessment could lead to over or under taxation relative to other properties within the municipality. The last revaluation in Carneys Point was conducted in 2018.

REVALUATION PROGRAM

A revaluation program seeks to spread the tax burden equitably within the municipality. Two properties having essentially the same market value should be paying essentially the same amount in property taxes.

Inequitable assessments may result from the following situations:

- Characteristic changes in neighborhoods and/or characteristic changes to individual properties within the municipality.
- Changes in the economy (inflation, recession, housing market supply and demand, interest rates)
- Custom changes to a house (remodeling, updating, additions)
- Changes in Zoning

REVALUATION PROGRAM PROCESS

- The interior and exterior of property will be inspected by personnel of the appointed Revaluation firm.
- The building materials and dimensions will be recorded.
- Photographs will be taken of the front and rear of ALL structures.
- Recent sales are studied and adjusted to estimate the value of properties that have not sold.
- Investment properties are analyzed in terms of income-production capability.
- All information that may have influenced (positively or negatively) the value of the property will be gathered and analyzed in order to determine the full and fair market value of each property.
- Prior to the new value being officially listed on the 2025 Tax List, the revaluation firm is required to mail each taxpayer a notice of new assessed value. The mailing is usually after November 10, but prior to December 31.
- The notice will include guidance on how to arrange for an informal hearing to review the Property Record Card. Taxpayers are encouraged to make an appointment to view the accuracy of the data collected, provide additional information about their property and to discuss the proposed assessment.

FARMLAND ASSESSMENT

New Jersey's Farmland Assessment Act of 1964, administered by the New Jersey Department of Treasury, provides for the lower assessment-based productivity of farmland if it meets specific eligibility criteria. To qualify for the tax assessment reduction, a landowner must have no less than five acres of farmland actively devoted to an agricultural or horticultural use for the two years immediately preceding the tax year being applied for and must meet specific minimum gross income requirements based on the productivity of the land.

The owner or owners of the land used for agriculture or horticultural purposes may apply for assessment of the land under the Farmland Assessment Act by filing Form FA-1, which is



available from the respective municipal tax assessor. Woodland owners must file in addition to the Form FA-1 a completed Woodland Data Form (WD-1) and a copy of their woodland management plan. Form FA-1 and WD-1, if required, must be filed annually with the tax assessor on or before August 1st of the year preceding the year for which Farmland Assessment is being applied.

For existing Farmland Applicants, please anticipate receiving your 2025 farmland paperwork from our office on or around June 1st. Please remember ALL applications are due on or before August 1, 2024. Late or incomplete applications are subject to denial.

Online Tax Payment Portal

A quick link available through our website carneyspointtwp.org allows the convenience of online tax payment and general property information access.

Payments take at least 24-72 hours to process while a confirmation number does not confirm payment

The payer is responsible for verifying the correct property account paid. Be sure to verify the account, as once the payment is processed the Tax Office cannot make any refunds or corrections.

The Tax Office is not responsible for internet or system interruptions.

Tax account look up is for informational purposes only and does not constitute a Municipal Tax Search. Account information is subject to updates, corrections, and reversals. Carneys Point Township is not responsible for erroneous interpretation of the records or for changes made after the look up.

\$250 Senior/Disabled/Surviving Spouse Deduction:

As a qualified senior citizen/disabled person/surviving spouse, you will receive a deduction of \$250 from your yearly taxes billed.

\$250 Veteran Deduction:

As a qualified veteran/surviving spouse, you will receive a deduction of \$250.00 from your yearly taxes billed.

100% Disabled Veteran Exemption:

As a qualified 100% disabled veteran/surviving spouse, you will receive an exemption on your yearly taxes billed.

Anchor Program (Formerly the Homestead Rebate Benefit):

An application with instruction is sent by mail to qualified applicants. Contact phone number: 1-888-238-1233.

Property Tax Reimbursement/"Senior Freeze Program"
/Blue Book:

Although it does not freeze your taxes, this program offers a refund of taxes paid with met eligibility requirements and completed application. A base rate is set the year you apply and are eligible with any increase in taxes paid from year to year thereafter being reimbursed. Initial applications only are available in the Tax Collectors Office, Office of the Aging, or State of New Jersey. Once enrolled, applications are mailed yearly to the applicant. The verification of taxes paid form must be completed by the Tax Collectors Office and mailed with the application. Contact phone number: 1-800-882-6597

** The Anchor Program and Property Tax Reimbursement are separate State of New Jersey administered programs.

Police Department

The Route 140 (Hawks Bridge Road) overpass is open! It's not fixed, but it's great to see progress. Hopefully, we should start seeing a decrease in commercial vehicles driving through town. The extra vehicles caused an increase to first responder services (accidents, stuck vehicles, commercial vehicles in residential neighborhoods, etc.), which should decline or stop. I believe everyone is happy the roadway is finally open.

If you have driven by the police department lately, you will see that the rear parking lot has been expanded. We now have parking against the building, as well as along the wood line for police vehicles and officer's personal vehicles. In the past year, we've had up to nine officers working at one time between patrol shifts and road details. There were times a function was happening at the municipal building and parking was limited. The expansion was definitely needed. While talking about road details, I want to make sure the public knows that officers assigned to road details are getting paid by that specific company and are not getting paid by the township. I hear a lot of people say their taxes are paying for the officer to do nothing, but this is one hundred percent wrong.

At the township committee meetings and throughout the day, I hear complaints about traffic, vehicles passing school buses stopped for children, vehicles running traffic lights and stop signs, people speeding, loud music, trucks in "no truck" areas, people littering, people scrapping from abandoned properties, people living in trailers, squatters, animal complaints, etc.... We are aware of all the issues, and we try to address all of them, but we will never get them all. Throughout the weekday, officers are at each school in Carneys Point prior to the start and finish of the day, do walk throughs in the schools throughout the day, respond to accidents, investigations and anything else that comes in. We are starting to see and feel the additional people and traffic that is coming to and through the town. I made a request to the township committee to hire officers, and the township committee has approved hiring two full-time police officers in 2024. The increase is needed to keep the residents of Carneys Point and our officers safe.

Likewise, during 2023, the EMS division responded to over 3,000 Ambulance calls within our area.



From The Municipal Court

The Carneys Point-Pennsville Joint Municipal Court handles traffic and quasi-criminal matters that occur in the boundaries of Carneys Point Twp. and Pennsville Twp. The office is open to the public 8:30 am - 4:00 pm Monday - Friday (excluding holidays). Court staff can be reached by phone by dialing (856) 299-1013 and our fax number is (856) 299-8926. For your convenience, payments for most payable tickets and time payment plans can be made online, the web address is WWW.NJMCDIRECT.COM. The court office can accept credit card payments for all traffic and criminal fines, - proper identification is needed to process the transaction. After hours, payments/correspondence can be placed in the lockbox labeled "Carneys Point Joint Court".

Court sessions remain VIRTUAL – with limited in-person

appearances. If you are scheduled for a court, please call (856) 299-1013 to ensure we have your updated contact information.

Did you know you can dispute your case online? The Online Municipal Case Resolution System allows you to dispute your traffic ticket without having to appear in court. When a ticket is disputed online, the Municipal Prosecutor may recommend an amendment to the original offense. You will have the option of accepting or rejecting the amendment. If the amendment is accepted the Judge will assess fines and costs (if applicable). If fines and costs are assessed, your payment plan will be mailed to you. All of this can be done from the comfort of home, no need to appear in court. The web address is WWW.NJMCDIRECT.COM. Court personnel are available during normal business hours to assist you.

Landlord Registration Form

For rental properties in Carneys Point Township, New Jersey State law requires landlords who rent houses, apartments or buildings to register certain information with the Municipal Clerk. This is to be done every six months or with every new Certificate of Occupancy. This is for any single unit dwelling or two-unit dwellings that is not owner occupied. The landlord must make sure the tenant receives a copy. The Landlord Registration Form is available at the Municipal Building in the Clerk's Office. The completed form needs to be filed with the Municipal Clerk.


