City Secretary, Jasmine Guy presented the agenda item. She shared that the City Officials Election held on May 3, 2025 for Place 1. Matthew Southard filed to challenge incumbent Eric Fleming. The following votes were cast:

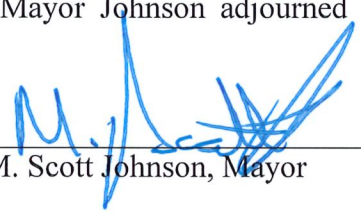
