

**Start of official Canvass for the  
November 3, 2009 General Election**

\*\*\*\*\*

**November 16, 2009, 9:00 a.m.**

Director Miller led the Pledge of Allegiance. Chairman Rick Combs called the meeting to order at 9:03 a.m. Board Members present were Rick Combs, Paul Campbell, Ric Ferenc and Dave Lane. Also present were Judy Miller – Director, Mike Keeley – Deputy Director and Becky Rudd – Clerk taking record.

**OTHER ATTENDEES:** Shekar Jayaraman – Field Liaison.

**TEST DECK :**

Ric Ferenc and Paul Campbell observed Nick Sommer (ISD) run the Test Deck Ballots thru the 650 scanner. Ric Ferenc then read the ballots as Rick Combs, Paul Campbell and Dave Lane hand tallied the results. The Board found the results to match the computer count and that the 650 scanner was counting accurately.

**2009-112** – Paul Campbell made the motion to accept and Verify the Results of the Test Deck. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

**PROVISIONAL BALLOTS:**

Director Miller explained the breakdown of the Provisional Ballots. There were 690 Provisional Ballots cast, 68 were invalid and 622 were valid. She reminded the Board that they may have to review any “over vote” or “blank” provisional ballots.

**“INVALID PROVISIONAL BALLOTS THAT SHOULD NOT BE COUNTED”:**

There were 68 Provisional Ballots that were determined to be invalid. Of those ballots: 1 did not sign the envelope, 1 was a new address out of the County, 22 were not registered, 26 voted in the wrong precinct and 18 did not show or have ID listed.

**2009-113** – Dave Lane made the motion to reject and not count the 68 Provisional Ballots that the staff determined to be in invalid for the previously mentioned reasons. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

**“VALID PROVISIONAL BALLOTS THAT SHOULD BE COUNTED”:**

There were 622 valid Provisional Ballots.

**2009-114** – Dave Lane made the motion to accept the 622 Provisional Ballots that the staff determined to be valid. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

## **ABSENTEE BALLOTS**

Director Miller reminded the Board that civilian absentee ballots that are postmarked before Election Day (11-3-09) and received within ten (10) days after the election (11-13-09) are valid absentee ballots. Military and overseas civilian absentee ballots may be postmarked on Election Day and received within the 10 day period are valid absentee ballots. There were 34 absentee ballots that were postmarked prior to Election Day, 3 military and 1 overseas civilian absentee ballots postmarked on or before Election Day, all received within the 10 day period and are valid ballots (38).

There were 9 absentee ballots with illegible postmarks for Board determination. The Board determined 1 envelope to have a valid postmark.

**2009-115** – Paul Campbell made the motion to add the 39 absentee ballots that were received within the 10 day period (with a valid postmark) that the staff determined to be valid and add them to the count, and reject the 48 absentee ballots that did not have valid postmarks. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

## **BALLOTS IN M100 EMERGENCY SLOT:**

Director Miller explained that per the Secretary of State’s Office, any ballot (at the polls) that can not be read thru the M100 reader must be put in the secured “emergency slot” of the reader stand. Those ballots are then collected at the close of the polls, put in an envelope and returned with the voted ballots to be counted on the 650 scanners Election Night. Several precincts placed this envelope in the blue supply bag and they were not discovered until the day after the Election.

The Board went off the Record at 10:10 a.m.  
The Board went back on the Record at 10:35 a.m.

Director Miller advised the Board of several ballots (emergency slot) that required duplication.

**2009-116** – Paul Campbell made the motion to duplicate, as it is indicated on the ballot, the ballots that were found in the M100 emergency slot. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

The Board went off the Record at 10:38 a.m.  
The Board went back on the Record at 11:17 a.m.

The Board reviewed the provisional “over vote and blank ballots” and made their determinations.

The Board went off the Record at 11:22 a.m.  
The Board went back on the Record at 11:30 a.m.

The ballots were duplicated per the Boards instructions.

**2009-117** – Dave Lane made the motion to instruct the office staff to proceed with the Official Canvass. Rick Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

**2009-118** – Rick Ferenc made the motion to reschedule the December Regular Monthly Board Meeting (12-24-09) to December 17, 2009 at 2:00 p.m. Paul Campbell seconded the motion. Upon roll call, all Members voted “yes”.

**2009-119** – At 11:34 a.m. Dave Lane made the motion to go into Recess. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

**The Board stands in Recess and will Reconvene November 24, 2009 at 2:00 p.m.**

**Certification of General Election  
Board Reconvenes November 24, 2009, 2:00 p.m.**

**The Board went back on the Record November 24, 2009 at 2:00 p.m.**

Chairman Rick Combs reconvened the meeting at 2:00 p.m. Paul Campbell led the Pledge of Allegiance. Board Members present were Rick Combs, Paul Campbell, Ric Ferenc and Dave Lane. Also present were Judy Miller – Director, Mike Keeley – Deputy Director and Becky Rudd – Clerk taking record.

**OTHER ATTENDEES:** Shekar Jayaraman – Field Liaison, Nick Sommer (ISD), Barrett J. Brunsmann – Cincinnati Enquirer

**TEST DECK AND CERTIFICATION:**

Dave Lane and Ric Ferenc observed Nick Sommer (ISD) run the Test Ballots thru the 650 scanner. Ric Ferenc read the computer results as Dave Lane compared them to the previous results and found them to match.

**2009-120** – Dave Lane made the motion to accept the results of the Test Deck. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

**2009-121** – Ric Ferenc made the motion to accept and Certify the results of the November 3, 2009 General Election. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

Director Miller stated that Hamilton County Certified their results on Saturday and those results (for overlaps) were added into ours for the final count.

#### **AUTOMATIC RECOUNTS:**

Director Miller explained that three (3) races qualify for an Automatic Recount. They are Moscow Village Council, Washington Township Trustee and New Richmond Exempted Village School Board. The declared winners in each race will not be recounted. The hand count will be 5% of the votes cast for each race. Each Board Member received a copy of Directive 2009-18, Recount Procedures. The Board scheduled the Automatic Recount for December 3, 2009 at 10:00 a.m. Those candidates involved will be notified by certified mail.

The Board entered into the Regular Monthly Meeting of November 24, 2009.

### **REGULAR BOARD MEETING**

November 24, 2009

#### **APPROVAL OF MINUTES:**

**2009-122** – Paul Campbell made the motion to accept the Minutes of the October 22, 2009 Board Meeting. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

#### **APPROVAL OF BILLS:**

**2009-123** – Paul Campbell made the motion to accept the Bills. Director Miller brought to the Board’s attention the entry for Alpha-Numeric LLC for the deployment of the voting equipment. It was originally \$9,875 and Mike was able to negotiate the price down to \$9,375. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

#### **BIDS ON PRINTING BALLOTS:**

Director Miller reminded the Board that if the cost for the ballot printing is greater than \$10,000 we must go out to bid (per code section). She brought to the Board’s attention a pilot program from Dayton Legal Blank (DLB). Cuyahoga County used this new program for the May 2009 Election. All requested absentee ballots are programmed into the Dims system; those files were sent to a DLB plant in Cleveland. DLB then prints the absentee ballots, stuffs everything (ballots, instructions etc.) into the envelopes, triple bar coded them and mailed them out for a cost \$1.40. They saved 1/3 on their postage. This could be a significant savings for us. The submitted bids do not allow an “option out” for this program. We could choose to not accept the bids at this time if we wanted to look into this program. Judy did consult the Prosecutor’s Office about the bid process. The Board thought this program might be something to consider in 2011 but not in the May Primary. It is still too new. Dave Lane asked if the program went

well in Cuyahoga County and Judy stated that it did. They performed a tracking audit and found no mistakes. There are several Counties that are ahead of us to try the program.

Seven Companies asked to be on the bid list: Dayton Legal Blank, ES&S, 3-G Graphic Solutions/Barrett Bros., MCR, Inc. (Mayfield Village), Midwest Direct (Cleveland, OH), Document Concept, Inc/RTM Tech (Canton, OH) and DDP Mailing & Electronic Printing. It was also advertised in the Clermont Sun.

The only companies to respond were Dayton Legal and ES&S. The Board opened the 2 bids. The ES&S bid was: 14 inch ballots-\$250 per thousand, additional sheets will be \$230 per thousand, price includes printing, packaged and delivered per Clermont County's specifications and also includes any additional color, stitching, numbering, and folding for absentees, packaging/labeling. Their bond (\$400,000) appears to be in order.

DLB bid was: 14 inch ballot = \$0.26 per general ballot, \$0.28 primary ballot, \$0.23 special ballot, additional \$0.03 to fold absentee ballots, \$0.04 for color identification, \$3.00 per ballot style, the cost for the pre-filled test decks will be identical to the ballots of each election, no additional charge for test deck files. Their bond is \$400,000.

Rick Combs inquired about the work product on the two companies. Judy was not familiar with ES&S. She did speak with Brown County BOE, which uses ES&S. They did not know where (location) the ballots are printed which is a concern for Judy.

**2009-124** – At 3:02 p.m. Ric Ferenc made the motion to take a 10 minute recess to allow the Director and Deputy Director time to analyze the bids. Paul Campbell seconded the motion. Upon roll call, all Members voted “yes”.

At 3:12 p.m. the Board went back on the record.

Upon examination DLB's bond, they (DLB) were using themselves and as acting as their own Surety and the Bond itself was a photocopy. The Director and Deputy Director consulted with Tom Blust – Prosecutor's Office, and he advised that DLB can not be their own Surety and being a photocopy it has no power attached to it and said “it is an invalid Bond and makes the bid invalid”. Judy and Mike compared the two bids for 100,000 ballots, and ES&S would be approximately \$48,000 and DLB would approximately be \$57,650.

**2009-125** – Ric Ferenc made the motion to accept the ES&S Bid on Ballots for the 2010 Election Year. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

**COMMUNICATIONS:** None.

#### **DIRECTORS REPORT:**

Director Miller reported that the County Commissioners approved the Appropriations for 2010. We had requested \$1,334,776. and they want us to reduce our budget to \$1,063,548. We budgeted for the two major elections (primary and general) and reduced the budget to \$1,095,776, but they still would like it lower. The final Appropriation was set at \$1,032,392. [They gave us \$1,113,759 for 2009 and we could have a remainder of \$46,000 (after the 2009 bills are paid) and if that is added to next year we should have approximately \$1,067,759.] Even with all of the cut backs we will still be short for next year. We are getting less money for a major election year than we received for an off year election. Judy said they are going to monitor the budget on a monthly basis and have a mid year adjustment.

The OAEO Winter Conference is scheduled for January 20-22, 2009 in Columbus at the Hyatt. Judy would like to send her, Mike and four (4) staff members. Rick Combs inquired about the cost. She said the conference fees were about \$130. per person, plus gas and meals. Several staff members do not like to spend the night because of family obligations. The hotel reservations need to be made and paid in advance. Paul Campbell and Dave Lane would like to attend. Rick suggested one Conference per year. Judy added a financial statement should be forthcoming for the OAEO.

Director Miller advised the Board of the upcoming May 3<sup>rd</sup> Gubernatorial Primary Election. The filing deadline is February 18, 2010 at 4:00 p.m. The Republican Party Central Committee voted to go to four (4) year terms (instead of the current 2 yr. terms) for their Central Committee Candidates and will still circulate petitions. A letter from the Republican Party will be forthcoming. The Democrat Party Central Committee will meet on December 6 to vote on the terms. Rick Combs inquired if this would save us any money. Judy and Mike said it would. Judy reminded the Board that it has always been a policy of the Board to print walking lists (paper and cd, at no cost) for each Party before a Primary Election.

**2009-126** – Paul Campbell made the motion to provide the walking lists, at no cost, to the Major Political Parties of Clermont County. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

#### **DEPUTY DIRECTOR’S REPORT:**

Deputy Director Keeley reported on the Polling Location changes made before the Election. He stated there were no complaints, no long lines and everything seemed to go well. He brought to the Board’s attention the Amended HB 260. Some of the topics included are same day voting and limiting to two (2) elections a year. Mike will email this to the Board Members.

#### **EXECUTIVE SESSION:**

**2009-127** – At 3:32 p.m. Paul Campbell made the motion to go into Executive Session for the purpose of personnel matters. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

**2009-128** – At 3:43 p.m. Paul Campbell made the motion to come out of Executive Session. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.

The result of Executive Session is the following motion.

**2009-129** – Paul Campbell made the motion for the Board to approve a day off for the entire Board of Elections staff Christmas Eve Day. Ric Ferenc seconded the motion. Upon roll call, all Members voted “yes”.


