

Chairman Tim Rudd called the meeting to order at 10:01 a.m. Rick Combs led the Pledge of Allegiance. Board Members present were Tim Rudd, Dave Lane, and Rick Combs. Paul Campbell was absent. Also present were Judy Miller – Director, Mike Keeley – Deputy Director and Becky Rudd – Clerk taking record.

**OTHER ATTENDEES:** Keith Corman – SOS Field Liaison and Donna Gunn.

**APPROVAL OF MINUTES:**

**2011-58** – Rick Combs made the motion to approve the minutes from the July 28, 2011 Regular Board Meeting. Dave Lane seconded the motion. Upon roll call, all Members present voted “yes”.

**APPROVAL OF BILLS:**

**2011-59** – Dave Lane made the motion to accept and pay the August Bills. Rick Combs seconded the motion. Upon roll call, all Members present voted “yes”.

**COMMUNICATIONS:**

Donna Gunn (in attendance at the meeting) submitted two letters to the Board properly filed on August 18, 2011. The first was a Letter Challenging the Voting Residency of Russell Whitley, Jr. Since Mr. Whitley filed a petition to run for Bethel Village Mayor, Donna Gunn filed a second letter contesting the Candidacy of Russell Whitley, Jr., for Bethel Village Mayor. She stated in her letter that since Mr. Whitley is not a residence of the Village of Bethel he would not be able to hold the office of Mayor. (Mr. Whitley was appointed to and is now on the Bethel Village Council.) March 14, 2008, Mr. Whitley changed his address from 2444 Bethel Hygiene Rd. (TE-F-BT) to 408 S. Main St. (BL-C).

**2011-60** – Rick Combs made the motion to hold a Protest Hearing regarding the issue of Rus Whitley as an elector of the Village of Bethel and to make a determination on his Candidate Petitions on August 29, 2011 at 10:00 a.m. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

**CERTIFICATION OF NON-PARTISAN CANDIDATES TO THE NOVEMBER 2, 2011  
GENERAL ELECTION BALLOT:**

Director Miller reviewed the Candidate Petitions with the Board. She advised them of the Petitions that required Board review.

**Kimberly S. Beuke** filed petitions for Clerk/Treasurer in Owensville Village on June 17, 2011. On July 7, 2011, she submitted a letter to withdrawal her petitions. She sent another letter on July 15, 2011 asking to have her name appear on the ballot. Judy checked with Gretchen Quinn – Secretary of State’s Office, she stated that there is nothing in the Code that allows her to rescind a withdrawal.

**C. Robert Pollitt** (Petition filed for Amelia Village Mayor) and **Bruce Spencer** (Petition filed for Newtonsville Village Mayor) submitted letters of Withdrawal of Candidacy.

Paul Vanderbosch failed to write in office and village on the Statement of Candidacy on part petition #4. James Constable failed to write in Clermont on part petitions #1 & 3 on Statement of Candidacy. Ken Tracy failed to complete his address on part petitions #1, 2, & 3 on circulator statement, he did sign and complete the total number of signatures.

Eric Kelso failed to check the box for full term on part petitions #1 & 2 on Statement of Candidacy, full term was checked on Nominating Petition section on part petitions #1 & 2. Allen R. Carrier-on part petition #1, lines 2 & 3 it appears a wife signed for her husband. Cynthia Lohr Shircliff's address on petitions is 5764 Stonelick Williams Corner Rd. and in the system, it is 5760 Stonelick Williams Corner Rd. Teresa Battista- reviewed signatures for determination of validity. Anthony R. Staubach- reviewed signatures for determination of validity. After reviewing and discussing each candidate's petitions, the Board made the following motions.

**2011-61** – Rick Combs made the motion to accept the Letters of “Withdrawal of Candidacy” for C. Robert Pollitt for Amelia Village Mayor, Bruce Spencer for Newtonsville Village Mayor and Kimberly S. Beuke for Owensville Village Clerk/Treasurer. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

**2011-62** – Rick Combs made the motion to accept the petitions of Paul Vanderbosch for New Richmond Village Council and Certify him to the ballot. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

**2011-63** – Rick Combs made the motion to accept the petitions of James Constable for Goshen Township Trustee and Certify him to the ballot. Dave Lane seconded the motion. Upon roll call, all members voted “yes”.

**2011-64** – Rick Combs made the motion to accept the petitions of Ken Tracy for Miami Township Trustee and Certify him to the ballot. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

**2011-65** – Rick Combs made the motion to accept the petitions of Eric M. Kelso for Monroe Township Trustee and Certify him to the ballot. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

**2011-66** – Dave Lane made the motion to accept the petitions of Allen R. Carrier for Wayne Township Trustee and Certify him to the ballot. Rick Combs seconded the motion. Upon roll call, all Members voted “yes”.

**2011-67** – Dave Lane made the motion to accept the petitions of Cynthia Lohr Shircliff for Clermont Northeastern School Board Member and Certify her to the ballot. Rick Combs seconded the motion. Upon discussion, the Board stated she needed to update her address as soon as possible. Upon roll call, all Members voted “yes”.

**2011-68** – Dave Lane made the motion to accept the petitions of Teresa Battista for Felicity Franklin School Board Member and Certify her to the ballot. Upon roll call, all Members voted “yes”.

**2011-69** – Dave Lane made the motion to reject the petitions of Anthony R. Staubach for Milford Exempted Village School Board Member, as petition did not contain enough valid signatures. Rick Combs seconded the motion. Upon roll call, all Members voted “yes”.

**2011-70** – Rick Combs made the motion to accept the petitions of all other Candidates with the exception of C. Robert Pollitt (Amelia Village Mayor), Bruce Spencer, Kimberly S. Beuke and Anthony R. Staubach and Certify them to the ballot, list attached. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

**2011-71** – Rick Combs made the motion to accept the Candidate Name Requests for the ballot, list attached. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

**CERTIFICATION AND APPROVAL OF QUESTIONS & ISSUES:**

Director Miller reviewed the Questions and Issues with the Board. She advised them that on the recommendation of Dave Frye, Assistant Prosecutor, the Resolution filed by the Village of Felicity should not be placed on the ballot (ORC 5705.03).

**2011-72** – Rick Combs made the motion to Accept and Place the following Tax Levies on the November 8, 2011 General Election Ballot:

Monroe Township – Replacement Tax Levy-(3 mills for a continuing period of time) – for providing and maintaining a fire department

Monroe Township – Replacement Tax Levy-(3 mills for a continuing period of time) – for providing ambulance and /or emergency medical services

West Clermont Local School District – Additional Tax Levy-(7.9 mills for 10 years) – for emergency requirements of the school district

Clermont County – Renewal Tax Levy-(1.3 mills for 5 years) – for providing or maintaining senior citizens services or facilities

Village of Bethel – Renewal Tax Levy-(2 mills for 5 years) – for general road construction

City of Milford – Additional Tax Levy-(10.5 mills for 3 years) – for fire and ems

Village of New Richmond – Additional Tax Levy-(2.5 mills for 5 years) – for general road construction

Village of New Williamsburg – Renewal Tax Levy-(5 mills for 5 years) – for current operating expenses

**Tax Levies from Overlapping Counties**

Blanchester Local School District – Replacement and Increase Tax Levy-(1.5 mills for 5 years) – for improvements, renovations and additions to school facilities and equipment and furnishing and site improvements – overlap from Clinton County

Little Miami Local School District – Additional Tax Levy-(13.95 mills for 5 years) – for avoiding an operating deficit – overlap from Warren County.

Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

**2011-73** – Rick Combs made the motion to reject the Renewal Tax Levy filed by the Village of Felicity- 3.5 mills for 5 years for current operating expenses, for not following the proper procedures as stated in R.C. 5705.03 upon the recommendation of Legal Counsel.

Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

Judy advised the Board that all of the Local Option Petitions that were filed for this November 8, 2011 General Election were in proper order.

**2011-74** – Dave Lane made the motion to Certify and place on the Ballot the following Local Options:  
Bethel Village C – Bethel Petro, Inc., dba Bethel BP – 308 W. Plane St. (single site) Sunday Sales of beer - (11 a.m. and midnight)

Miami Township B1B – Mac’s Convenience Stores, LLC dba Circle K #5558 – 1101 St. Rt. 28 (single site) Sunday Sales of wine and mixed beverages - (10 a.m. and midnight)

Union Township H – Speedway, LLC dba Speedway 9674 – 1267 Old St. Rt. 74 (single site) Sunday Sales of wine and mixed beverages - (10 a.m. and midnight)

Union Township N – Winedog LLC dba Winedog Internat’l Fine Wines – 451 Ohio Pike, Unit A (single site) Sunday Sales of wine and mixed beverages - (10 a.m. and midnight).

Rick Combs seconded the motion. Upon roll call, all Members voted “yes”.

**APPOINTMENT OF POLL WORKERS BY SEPTEMBER 15, 2011:**

The Board discussed the list of Democratic and Republican Poll Workers. The Board decided to table the Appointments until the Monday August 29, 2011 Special Board Meeting. Appointments need the vote of 3 Board Members which some of the appointments would not have since Tim Rudd has relatives on the list (and he will abstain from voting on) and Paul Campbell is absent.

**DIRECTOR’S REPORT:**

Director Miller reported that the Chargebacks for the Special Election of May 3, 2011 are completed. The chargeback to the County will be approximately \$81,620.00. The Board reviewed and signed the Chargebacks.

With regard to a questions that was raised at the last Board Meeting when reviewing Directive 2011- 11 (Withdrawal of Candidacy) as to whether a Full Term and an Unexpired Term for the same office is considered to be two separate offices, Judy advised that Gretchen Quinn at the SOS advised that they were considered to be 2 separate offices. This means that a candidate could withdraw from one term, and then take out petitions or be a write-in candidate for the other term.

Green County Board of Elections in Xenia, is holding the Fall District Meeting, Friday, August 26, 2011. Judy would like Bonnie Carlier, Tonia Blackburn, Jackie Smith, and Terrie Latham to attend. She feels it will be beneficial to attend this meeting with discussions on how to process the upcoming election with the pending election changes. If the committee we are Ohio purports to collect enough signatures by September 29<sup>th</sup> the new election changes from HB 194 will go on hold and that will move the 2012 Primary back to March. However, there is talk of Emergency Legislation that would move the Primary back to May.

Judy discussed the need for part-time employees for this November Election. She thinks 4 people should be adequate. Gregg Conrad (D) and Donna Brittain (R) have stated that they would come back and we will look for two additional employees.

Judy and Mike looked into precinct consolidation. If the new law goes into effect this does not have to be completed until December 31, 2011. They are planning to make no changes for the November 8, 2011 Election.

There was discussion with regard to the annexation by the Village of Batavia, the land where UC Clermont College and SODC are located that there is no residential property within that area. Judy is to check to see if there are any voters who reside at SODC.

Judy updated the Board about the Electronic Pollbooks. She stated that during the Convention there was talk about using leftover HAVA money toward the purchasing of Electronic Pollbooks. Judy spoke with Matt Masterson at the Secretary of State's Office and was told that there would not be any HAVA money going toward the E-Pollbooks. Judy had Nick Sommer contact the two main E-Pollbook vendors, ES&S and Data Card with regard to future demonstrations for the Board.

Steve Rabolt contacted our office on behalf of Dave Spinney, County Administrator, and stated to Judy and Mike that since it would take about \$1.8 million to replace our election equipment and the County does not have the money to replace everything at one time, starting in 2012 they are allowing approximately \$350,000 for election equipment replacement and upgrades over the next five years. This is part of the 5 Year Budget Plan that Dave Spinney has put together for the Commissioners. Steve Rabolt stated that these monies could be used for the purchase of the E-Pollbooks. Rick asked, "If we do not spend the money the first year, can we double the money to spend the second year?" (Judy and Mike are to get with Steve Rabolt to get an answer to that question.)

Judy attended the County Budget Meeting. They discussed the Annexation of the Filager Complex which does not affect our office which is located in the Village of Batavia and all employees are already having the 1% Income Tax withdrawn from their salaries. They also discussed Health Insurance. The program is going to cost about \$1,000,000.00 more a year. One person from each office is being designated to be on the Employee Advisory Council Recommendation. That Employee Advisory Council has recommended to the Commissioners that they do not make any changes to the program and are asking the Commissioners to absorb any cost increases since there have been no raises over the last 4 years.

Judy advised the Board that the **Southern Ohio Educational Service Center** has redistricted. Our candidate for the Southern Ohio Educational Service District (in which Blanchester Local School District is located - Precincts of Wayne Township A and D) will now be located in Sub-District #2 and will run for a 2-year term this year (2011) only. Starting in 2013, the candidate for that district will run for a 4-year term.

**DEPUTY DIRECTOR'S REPORT:**

Deputy Director Keeley reported to the Board that the annex renovation has started. The wall in the absentee voting room has been moved outward, which gives us about another 8 feet in the room. The air exchange has been ordered and should be installed by the time the remodeling is completed.

Rick inquired if Commercial Works had settled with us regarding the damages from the ballot boxes. Mike stated that they had.
