

Chairman Tim Rudd called the meeting to order at 6:30 a.m. Rick Combs led the Pledge of Allegiance. Board Members present were Tim Rudd, Dave Lane, Rick Combs, and Paul Campbell. Also present were Judy Miller – Director, Mike Keeley – Deputy Director, and Becky Rudd – Clerk taking record.

OTHER ATTENDEES: Dave Bell

OPEN POLLS:

2014-44 – Rick Combs made the motion to formally Open the Polls for the May 6, 2014 Primary Election. Dave Lane seconded the motion. Upon roll call, all Members voted “yes”.

The Board went off the record until the Director entered the meeting.
The Board went back on the Record after the Director entered the meeting.

Director Miller explained to the Board the Absentee Ballots that required Board review for blank ballots, ballots with indeterminate marks, double-bubbles, over votes and Write-Ins. Judy explained that according to the Directive the only Write-In Candidates that need to be reported Election Night, that have to be hand counted are the statewide Write-In Candidates (Green and Libertarian) and other races where there is competition. There are 3 contested Central Committee races on the Republican Ballot: Miami Township K, Union Township E and Union Township P1P. In order for there to be a valid vote for a Write-In Candidate, the Directive basically requires the voter to fill in the oval and write-in the candidate's name on the appropriate line in order to be counted. Tim reviewed the Directive and Dave agreed with the decision that the oval must be filled in.
The Board proceeded with the Write-In tallies.

At 7:07 a.m. the Board went off the record while Tim hand counted the Write-In Ballots for County Commissioner.

At 7:13 a.m. the Board went back on the record.

Judy reminded the Board that the Democratic Commissioner Write-In Candidate must garner 50 valid write-in votes to go onto the November ballot. Judy recommended that the Board reconvene at 5:00 p.m. at which time they will run the Test Deck prior to the Election Day count and any additional absentee ballots, that come in today, requiring Board review.

At 7:14 a.m. the Chairman stated the Board will stand in recess until 5:00 p.m.
At 5:15 p.m. the Board reconvened.

Judy advised the Board that the Test Deck will be run on ballot reader #4. This is the reader that will be used to count the ballots.

The Board went off the record at 5:15 while Dave and Rick observed the Test Deck run thru the 650 scanner. Tim, Dave and Rick compared the results to the control sheet and prior test deck and found the results to match and that the computer was counting accurately.
The Board went back on the record at 6:12 p.m.

2014-45 – Paul Campbell made the motion to accept the Results of the Test Deck. Rick Combs seconded the motion. Upon roll call, all Members voted “yes”.

The Board reviewed the additional Absentee Ballots that were in today’s mail (postmarked prior to May 6, 2014).

2014-46 – Rick Combs made the motion to allow the staff to work split shifts on the day after the election, May 7. Paul Campbell seconded the motion. Upon roll call, all Members voted “yes”.

Judy advised the Board that Edna and Mike will run the remaining Absentee Ballots thru the vote remote at 7:00 p.m. The Board will make any necessary determinations on those ballots and the ballots will then be run thru the 650 scanner and added to the count.

Judy reminded the Board that our County was selected to report results to the SOS every 15 minutes. Jackie has prepared all of our Mock Election Updates and the SOS tested their equipment to accept the reports.

We did not receive emails from the SOS (from the SOS computer) because of a power failure and after being contacted by the SOS we were able to complete the required testing. Mike contacted the SOS and suggested that they send us a battery back-up for that computer - which they did.

At 6:40 p.m. the Chairman stated the Board will stand in recess.
The Board went back on the Record at 7:30 p.m. to announce the Closing of the Polls.

The Board commenced with the counting of the Absentee Ballots at 7:31 p.m. until all 166 Precincts were in and Counted. The Final Unofficial Results were tabulated by 9:40 p.m.

At 9:42 p.m. the Board conducted the final run of the Test Deck.

2014-47 – After completing the final run of the Test Deck and noting that the computer was counting accurately, Paul Campbell made the motion to accept the results of the Test Deck. Rick Combs seconded the motion. Upon roll call, all Members voted “yes”.


2014-48 – Rick Combs then made the motion to **Accept** the **Unofficial Results of the May 6, 2014 Primary Election and post the results.** Paul Campbell seconded the motion. Upon roll call, all Members voted “yes”. (See attached Unofficial Results)




