Judy advised the Board that the County may be looking into another phone system; our phone system has been a problem. At 7:55 a.m. the Board stands in Recess.

At 5:51 p.m. the Board went back on the record from Recess and stated that they will run the Test Deck of selected races.

At 5:51 p.m. the Board went off the record to read and compare the Test Deck to the Control Sheet.

At 6:46 p.m. the Board went back on the record. They completed the comparison of the Test Deck and the Control Sheet.

2015-113 – Larry Heller made the motion to accept the Results of the Test Deck as was run of selected races. Ray Lembke seconded the motion. Upon roll call, all Members voted “yes”.

At 6:47 p.m. the Board went off the record while the latest Absentees were run through the 850 scanner. The Board waited to review those ballots that would require Board review.

At 10:34 p.m. the Board went back on the record. The Board was provided with the Unofficial Results of the Election.
