Chairman Rick Combs called the meeting to order at 10:02 a.m. Paul Campbell led the Pledge of Allegiance. Board Members present were Rick Combs, Paul Campbell, Larry Heller and Raymond Lembke. Also present were Judy Miller – Director, Mike Keeley – Deputy Director, and Becky Rudd – Clerk taking record.

OTHER ATTENDEES: Beth Hamad – SOS Liaison

#### TEST DECK:

Judy advised the Board that due to the amount of candidates (127 candidates and 94 offices) in this election we will run the full Test Deck to cover every race.

At 10:05 a.m. the Board went off the record while Ray and Larry observed Dan Shebesta (ES&S) run the Test Deck through the 850 scanner.

At 10:40 a.m. the Board went back on the record. The Chairman stated that the Board would move forward with the regular meeting and continue the Test Deck later in the meeting.

The Board resumed the Test Deck. Dan explained that with the new location of the DS200's being off site (Red Barn) from the central scanner (850 scanner at the BOE office) one precinct of the test deck ballots was left at the Red Barn and it wasn't discovered until we ran the ballots on the 850 scanner this morning. We now have those ballots and the totals were zeroed out and the test deck was rerun.

At 11:31 a.m. the Board went off the record to rerun the Test Deck, Ray and Larry observed Dan run the ballots through the 850 scanner.

At 11:48 a.m. the Board went back on the record.

At 11:49 a.m. the Board went off the record to read and compare the results of the test deck to the control sheet.

At 12:13 p.m. the Board went back on the record.

**2015-104** – Ray Lembke made the motion to accept the results of the Public Test for the November 3, 2015 General Election. Larry Heller seconded the motion. Upon roll call, all Members voted "yes".

#### APPROVAL OF MINUTES:

**2015-102** – Ray Lembke made the motion to approve the minutes from the September 24, 2015 Regular Board Meeting. Larry Heller seconded the motion. Upon roll call, all Members voted "yes".

## APPROVAL OF BILLS:

**2015-103** – Paul Campbell made the motion to approve and pay the bills as of October 22, 2015. Larry Heller seconded the motion. Upon discussion Paul inquired about the highlighted portion of the bills and Judy advised him that those bills were submitted after she had emailed them to the Board Members. Upon roll call, all Members voted "yes".

# **DIRECTOR'S REPORT:**

Director Miller went over the projected budget with the Board. She advised that we try to keep the budget on target with what we need. We did need additional items for the new Electronic Pollbooks (power strips and electrical cords). We had a reduction in the cost for the Maintenance Contracts for the Election Equipment because the contracts were coming due in May and therefore we did not have to pay it from this May 2015 to May 2016. It will pick up in next year's budget. This years left over money will go back into the general fund and be used next year. We have the largest amount of chargebacks in the odd year elections. We are expecting a 50% turnout, next year (2016) we expect a 72% voter turnout. It may

take \$200,000 more for the 2016 General Election. Our Budget Request for the next year is sent to OMB in the middle of May and re-adjusted in November of each year. This year they wanted us to make the adjustment in October. Judy would like the Board to take it under advisement to consider a raise for the poll workers in 2017. Rick asked what was put in for personnel pay. She said the county was looking at a 2% increase across the board. Judy advised that she put in \$1.00 per hour for each employee (4%). Rick also asked where she was on the classifications that Steve Rabolt asked for. Judy explained that to classify our staff against other county employees is difficult because our staff does so many different tasks; we have so many different phases. Rick thinks there is a classification that comes close or they may have to write another classification. He doesn't want us always falling in last because we are a hybrid. He wants this rectified while he is still on this Board. He wants to move forward on this. The Board Members shared their thoughts on how to best classify the staff. Judy will give the Board job descriptions of the employees. Paul asked how we are going to even them out. Paul suggested moving on with the meeting but we need to devote time specifically to this even if it requires a special meeting. The Board went back to the Test Deck during this time in the meeting.

Judy reported on the absentees to date:
18 UOCAVA requested and 2 returned,
3,226 Non UOCAVA,
164 applications from nursing homes and 81 people have been voted,
482 in office voters and 57 people took their ballot home.

Judy stated that the staff came in on Saturday (10-10-15) to work on the Fresh Start Act Petitions and completed them except for 10 parts. This required some overtime and with the extended hours and extra Pollbook Training there will be additional overtime.

Jerry Amick (ES&S) was here Tuesday (10-20) to upload the Electronic Pollbook data. We will have the absentee voter data downloaded in the E-Pollbooks next week. Thursday is the cut off and the data will be uploaded Friday; each Pollbook will be updated individually. We have not had any Observers file to date.

David J. Grenier, withdrew his candidacy on October 1, 2015 for Milford City Council. August 24, 2015 was the last day to withdraw and have their name removed from the ballot. The Hamilton County Board of Elections has been notified of his withdraw of candidacy.

**2015-105** – Ray Lembke made the motion to not count the votes for David J. Grenier at the Election on November 3, 2015 and make the appropriate postings at all voting precincts in the City of Milford per Ohio Revised Code 3513.30(D)(E). Larry Heller seconded the motion. Upon roll call, all Members voted "yes".

Kevin Horvath (ES&S) will again provide our Election Support and be here November 2-4. He knows our process and does an excellent job.

Dan Shebesta will be here next Thursday to start scanning the absentee ballots.

Per a notice from the Secretary of State the only recognized Minor Political Party is the Green Party.

### Annexation:

Judy advised the Board of the latest Batavia Village Annexations and gave the Board maps explaining them. This annexation caused two islands of Batavia Township A; per the code all precincts must be contiguous. A small portion of Batavia Township A will move into Batavia Township H and the larger portion will move into Batavia Township M. Judy also brought to the Board's attention the Lexington Run area in Batavia Township A. She had already planned on reducing that portion of Batavia Township A before the annexation happened. We are limited by the O.R.C when we can make these transfers. She wants these changes to take place the day after the election (November 4, 2015). Batavia Township H containing 711 voters with an increase of 12 voters for a total of 723. Batavia Township M containing 859 voters with an increase of 88 voters for a total of 947. Batavia Township I containing 850 voters with an increase of 372 voters for a total of 1,222.

**2015-106** – Ray Lembke made the motion to move the area incorporate by that portion of Filager Road that ends at Jessica's Way, Meghan's Run, Jessica's Way and Jessica's Chase from Batavia Township A to Precinct Batavia Township M, as indicated on Map B – Re-precincting effective November 4, 2015. Paul Campbell seconded the motion. Upon roll call, all Members voted "yes".

**2015-107** – Larry Heller made the motion to move the property situated in Batavia Township A (which includes the properties located at 4512, 4500, 4508, 4492, 4448 and 4006 State Route 222 to Batavia Township H, as indicated on Map B – Reprecincting effective November 4, 2015. Paul Campbell seconded the motion. Upon roll call, all Members voted "yes".

**2015-108** – Larry Heller made the motion to move the portion of Batavia Township A located south of State Route 32 to Old state Route 74 to Batavia Township I, as indicated on Map C – Reprecincting effective November 4, 2015. Ray Lembke seconded the motion. Upon roll call, all Members voted "yes".

## **OAEO** Winter Conference:

Judy gave the Board agendas for the January 13-15, 2016 OAEO Winter Conference to be held at the new Hilton Hotel in Columbus.

#### DEPUTY DIRECTOR'S REPORT:

Deputy Director Keeley advised the Board that we had an additional expense of \$3,000 for electrical equipment for the Electronic Pollbooks.

The training for the Rovers is scheduled for October 29, to be held in this office.

We have hired two new temporary employees; Barb Hudson-NP and Robin Grippa-R.

Paul asked if we had more Rovers because of the new Pollbooks. Judy stated that we are going with six; we usually have four. Paul stated that we don't want to shorthand ourselves and if we have the money he would rather have the extra help then have a problem.

Mike advised the Board that we had a disgruntled PEO (Poll Worker), Milt Tatter, and decided to let him go.

2015-109 – Larry Heller made the motion to terminate the services of Milton Tatter in Miami Township D1D as provisional clerk, effective immediately. Ray Lembke seconded the motion. Upon roll call, all Members voted "yes".

**2015-110** – Ray Lembke made the motion to follow the County Holiday Schedule. Larry Heller seconded the motion. Upon roll call, Ray Lembke – "yes", Larry Heller – "yes", Paul Campbell – "yes", Rick Combs – "no".

Larry asked if a Board Member is contacted on Election Day with an issue/question, what the chain of command to call someone is. Rick stated that he defers it Judy and Mike; they are equipped to handle it. Rick will not make any decisions at the Goshen Township polls because he works in Goshen. Paul added it is important to not put ourselves in a position to placate disgruntled PEO's (Poll Workers). Paul refers them to the BOE. We have sent Mary Lynne Birck (Prosecutor's Office) to the polls to handle certain situations.

Larry stated he did have someone ask him a question regarding paying people to pass out literature at the polls. The Board discussed the issue.
