## MOTION TO ADOPT THE AGENDA AS PRESENTED:

2017-76 – Ray Lembke made the motion to Adopt the Agenda as Presented. Larry Heller seconded the motion. Upon roll call, all Members voted "yes".

#### **APPROVAL OF MINUTES:**

2017-77 – Larry Heller made the motion to approve the July 27, 2017 Regular Board Meeting minutes. Ray Lembke seconded the motion. Upon roll call, all Members voted "yes".

#### APPROVAL OF BILLS:

Director Miller pointed out to the Board that the first payment for the annual warranty/maintenance fee for the DS-200's and DS-850 is on this month's bills.

2017-78 – Larry Heller made the motion to approve and pay the bills as of August 15, 2017. Ray Lembke seconded the motion. Upon roll call, all Members voted "yes".

# Certification of Candidates and Questions and Issues to the General Election Ballot of November 7, 2017

#### Candidates:

Judy reviewed the process for candidates to withdrew their petitions whereby a candidate may withdraw their petition before the Board takes action on it and refile by the August 9<sup>th</sup> filing deadline. If the Board takes action on a petition and the petition is rejected that candidate cannot file as a write-in candidate.

2017-79 – Paul Campbell made the motion to accept the letters of withdraw from the following candidates to withdraw their petitions; Tiffiany Riddle (Bethel Tate School Board-full term), Gary Stephens (Bethel Tate School Board-unexpired term), Tom Bixler (Goshen School Board), David Peters (Washington Township Trustee), who refiled their petitions and Paulette Smith (Bethel Village Council) and Gary Jordan (Williamsburg Township Trustee). Larry Heller seconded the motion. Upon roll call, all Members voted "yes".

Judy advised the Board that there were petitions that required Board review. The Board reviewed the petitions requiring review by the Board and had questionable and non-genuine signatures.

At 10:55 a.m. the Board went off the Record to wait for Mary Lynne Birck (Prosecutor's Office). At 10:58 a.m. the Board went back on the Record and Mary Lynne Birck entered the meeting.

At 11:13 a.m. the Board went off the Record so Mary Lynne could review the questions regarding the petitions.

At 11:25 a.m. the Board went back on the Record.

Mary Lynne advised the Board with regard to Petitions where it was obvious that one signer signed their own name and then "possibly" signed another person's name. **2017-86** – Larry Heller made the motion to certify the following Local Liquor Option Petitions and place them on the November 7, 2017 General Election ballot:

Milford City "G" – RJM Management LLC dba Lehr's Prime Market, Sunday Sales of spirituous liquors (10 am to midnight),

Monroe Township "D" – DJ's General Store, Inc., Sunday Sales of beer, wine and mixed beverages and spirituous liquors (10 am to midnight), and

<u>Williamsburg Village "C"</u> – Hilltop One Quick Stop, LLC dba Marathon, Sunday Sales of wine and mixed beverages and spirituous liquors (10 am to midnight). Ray Lembke seconded the motion. Upon roll call, all Members voted "yes".

Judy gave the Board the lists of Democratic and Republican Precinct Election Workers for review. She also advised the Board to remove one PEO from the Republican list as she did not respond back to us.

2017-87 – Ray Lembke made the motion to appoint the Precinct Election Workers, Democrat and Republican, by September 15, 2017 with the exception of Sidnie Reed (D) and Marsha Heller (R). Larry Heller seconded the motion. Upon roll call, all Members voted "yes".

**2017-88** – Paul Campbell made the motion to appoint Marsha Heller (R) as a Precinct Election Worker by September 15, 2017. Seconded by Ray Lembke. Upon roll call, Paul Campbell – "yes", Larry Heller – "abstain", Ray Lembke – "yes", and Rick Combs – "yes".

**2017-89** – Ray Lembke made the motion to appoint Sidnie Reed (D) as a Precinct Election Worker by September 15, 2017. Larry Heller seconded the motion. Upon roll call, Paul Campbell – "abstain", Larry Heller – "yes", Ray Lembke – "yes", and Rick Combs – "yes".

Chairman Combs read into the record the retirement letter from Director Judy Miller effective December 31, 2017.

Upon discussion Paul stated she is something to behold in this office. Rick added that she has done a very good job and has made it easy for him and he wishes her well and is always welcome. Ray stated that she has been a tremendous help to him and is sad to see her go. Larry also wishes her well. Rick reminded Julia to contact the Secretary of State of this notice. Upon roll call, all Members voted "yes".

#### Advertisement of Deputy Director Position:

Judy discussed the advertisement for the Deputy Director position. Judy contacted the Secretary of State's Office and their advice was to make Julia the Director and advertise for a Deputy Director position (effective January 1, 2018) and a Democrat Board Member will become chairman of the Board. That person will come in as an interim trainee effective on or about September 25, 2017. We need to request from the Commissioners addition money to cover the cost of hiring a Deputy Director and an increase in the poll worker pay. Judy has the letter ready for the Board to sign.

At 12:26 p.m. the Chairman requested to go off the Record for a brief recess. At 12:29 p.m. the Board went back on the Record.

Paul would like to know when the final advertisement is ready.

2017-91 – Paul Campbell made the motion to approve the advertisement for Deputy Director position effective on January 1, 2018 with interim training to begin not earlier than September 25, 2017 with 90 days' probation with a starting salary in the high \$50's. Ray Lembke seconded the motion. Upon roll call, all Members voted "yes".

## **Holiday Schedule Change:**

2017-92 – Larry Heller made the motion to approve a holiday for staff on December 26, 2017 in place of the Veteran's Day holiday scheduled for November 10, 2017, which is in the middle of the General Election Certification cycle. Paul Campbell seconded the motion. Upon roll call, all Members voted "yes".

#### **RESOLUTIONS:**

Chairman Combs read into the minutes a Resolution for Stephen Rabolt retiring County Administrator. The Board agreed he has done a wonderful job and has been very helpful to this Board.

2017-93 – Paul Campbell made the motion to approve the Resolution recognizing retiring County Administrator Stephen Rabolt for his years of service. Larry Heller seconded the motion. Upon roll call, all Members voted "yes".

#### **DIRECTOR'S REPORT:**

Judy reminded the Board of the situation with the Oasis Conference Center polling location. After talking to the Oasis regarding the contract, they advised that we can take out the "hold harmless and indemnification clause." It is satisfactory with Allen Edwards to cross out the desired paragraphs and initial the corrections in the contract. The Oasis prepared contracts for May and November 2018 with the increase to \$400 per election. Judy still thinks this is the best option and location for a polling location. We could look to make changes in 2019.

2017-94 – Ray Lembke made the motion to contract this year and next year with the Oasis Conference Center paying \$200 for the November 2017 election and \$400 for each election in 2018 (May and November); and we will renegotiate after the last election in 2018. Larry Heller seconded the motion. Upon roll call, all Members voted "yes"

Judy would also like to change the polling locations of Brandy Chase (UN-L) to the Withamsville Elementary School and the Milford American Legion (MD-A) to the Pattison School. Brandy Chase doesn't have a lot of parking and the Milford American Legion is not ADA compliant.

2017-95 – Paul Campbell made the motion to move the polling locations, as recommended by the Director, Deputy Director and staff, Brandy Chase (UN-L) to the Withamsville Elementary School and the Milford American Legion (MD-A) to the Pattison School. Larry Heller seconded the motion. Upon roll call, all Members voted "yes".

Judy advised the Board that Washington Township Firehouse #2 has been sold. There are three other locations available as polling locations. We are going to look at the other locations on August 24. Rick inquired that all voters in those precincts would be notified of the polling location changes.

Dan Shebesta (ES&S) is here today to start the ballot design. Brett Harbage is here working with the ADA.

Julia prepared all of the Local Liquor Option Ballot Language and SOS Notifications and did a great job.

#### **DEPUTY DIRECTOR'S REPORT:**

Julia gave the Board Members Clermont County lapel pins from the Commissioners. She has had several conversations with Mary Lynne Birck (Prosecutor's Office) regarding the personnel policy, which is still in progress. She also mentioned that Larry noticed some links from our website to the Secretary of State's website were not working but Robert Frost said they now should be working.
