Judy reminded the Board that only provisional voters could vote in the office today; voted absentee ballots may be dropped off until 7:30 p.m. to be valid and counted.

At 8:02 a.m., the Board went off the Record, they will return at 5:00 p.m. unless Judy needs them to reconvene prior to 5:00 p.m.
At 5:48 p.m., the Board went back on the Record to review additional absentee ballots for determinations. Beth Hamad entered the meeting at 5:48 p.m.

At 5:55 p.m., the Board went off the Record while Larry and Ray observed Will French (ES&S) run the test deck through the 850-ballot scanner.
At 6:30 p.m., the Board went back on the Record.

TEST DECK:

At 9:47 p.m. the Board went off the Record to run the test deck while Larry and Ray observed Will French run the test deck through the 850-ballot scanner.

At 9:50 p.m. the Board went back on the Record.

Rick read from the control sheet while Ray compared the results to the newly run test deck and found the results to match and that the computer was counting accurately.





