She advised the Board would be within the law to say it would be substantially compliant with the request. Mr. Lembke indicated that if there is nothing in the law that says we have to reject this, he is generally inclined to accept it.

He interprets this as, in a year that we are electing two commissioners in the same election then you are required to state the commencement date of the term you are running for, and when only one commissioner is being elected you are not required to state the commencement date.

Mr. Combs inquired if these candidates could have gotten this date from somewhere else. Deputy Director Dennison stated that there were three places on our website with commissioner term commencing dates, and in two places, the date was incorrect. This website information had the commissioner term date incorrect for some time.

The Board agreed that the incorrect term date was not a fatal error.
