C. May Special Election

Director Carney advised the Board that Bethel Village Council withdrew the tax levy they filed for the May Special Election. The Milford Exempted Village School District will be the only issue on the ballot. We are currently working on filling the poll workers, and will hold absentee voting in the office and not open the AV voting room. This election will be a good test for the Ballot on Demand.

D. Voting Locations and Training Locations for Milford/Miami Township We are looking for voting and training locations in the Milford/Miami Township area. We would like to consolidate two voting locations: St. James and the Oasis.

E. Red Barn Lease

The Red Barn Lease expires at the end of March. There is no county space at this time. We were offered a lease for the reception hall and could use it for training and equipment storage. Facilities could build a wall to separate the two spaces and secure the storage area. The county could also use this training space and are willing to take care of maintenance and utilities. A security system is already in place and it is climate controlled. County space could open up in two or three years. The Red Barn gave us several lease options. The Director will write up a 3-year lease contract with an option (to extend if needed), and have the Prosecutor's Office review it.

F. Reimbursement for Voting Equipment

Director Carney advised the Board that we are being reimbursed \$1,791,546.00 for voting equipment, per Senate Bill 135. We will submit receipts for equipment previously purchased (DS200 and the 850 scanner) and still have money for new equipment purchases. We recommend the purchase of the Ballot on Demand system for early voting, Express Votes, new ADA equipment to replace the automarks. We would have enough money to replace our old ballot scanner with a new 450 ballot scanner (\$44,000). This is all state money. Total reimbursement is \$1,250,000; this includes all deliveries, deployment, set-up, logic & accuracy, training of staff, and security seals. The county will be reimbursed in about 3 weeks.

IX. Deputy Director's Report

A. Purchase of Voting Equipment

Deputy Director Dennison added that the Express Vote is a complete package. It comes with a printer, kiosk, is mobile, can be used at nursing homes, and any voter could use the unit. ES&S is sending a technician back to train us on the Vote Remote during the May Special Election with live ballot envelopes.

B. Goshen Voting Locations

Deputy Director Dennison was following up on Mr. Combs request to look into polling locations in Goshen Township. There is a church, elementary schools, library, nursing home and Heritage Hall. The Board discussed the locations and he still needs to check them out further. Mr. Conrad doesn't see a need to move precincts out of the high school.
