The board discussed signature comparison for the ID envelopes with non-matching signatures. Per the statute, the board compared the voter's signature to their registration signature.

Director Carney informed the board that ballots were mailed to the nursing home voters and were held in their office until our staff arrived to help the patients vote. This process was more efficient than having multiple applications and ID envelopes to be completed while our staff was on-site at the nursing homes.

After reviewing the ballots, the board accepted one of the signatures and found a postmark on one of the envelopes that had been magnified on the projector screen. These two ballots will be counted. **2020-151** – Mr. Conrad made the motion to reject the 604 regular domestic civilian absentees that should not be counted. Mr. Combs seconded the motion. Director Carney reviewed the provisional ballots with the board. The ballots for this election had only one stub, so PEOs pulled some of the provisional ballots from the pads without stubs; two of them went through the DS200 and were included in the Election Day total, instead of being put in provisional envelopes.

Three provisional voters were sent an 11-S form due to an issue with their absentee ballots. They did not return the 11-S form but wanted to vote on Election Day instead and received provisional ballots. When Director Carney called the SOS, she was told a provisional ballot could not cure an invalid absentee ballot that was not a signature issue. Therefore those three provisional ballots must be ruled invalid.

For the provisional ballots that were missing a date of birth, the board (at least 3 members) can vote to accept the ballot if all the other requirements are met. The board accepted 4 of the 5 ballots that had no DOB. The fifth voter was not registered with the information provided.

The board decided to refer the three voters who voted twice to the Prosecutor.
