A. Election night report

The Director has been reviewing what can be done regarding the test deck for security purposes in the future. We can have a test deck and a second set of ballots to be used for the logic and accuracy testing. She will write a policy to review along with several other policies that are out dated.

B. DIMS licensing extension

Our DIMS contract is coming up for renewal, they are requesting a five year renewal. The Director is requesting a one-year contract with four additional annual year renewals. The contract is with the prosecutor's office for review. Hamilton County uses an ES&S product different from DIMS. Chairman Lembke inquired if there is a problem using Triad for the voter registration and ES&S for ballot tabulation.

C. Post-election audit

We are required to conduct a post-election audit. The races to be audited are the top of the ticket presidential and two countywide races. The Director would like to commence June 1 and conclude June 5.

Mr. Conrad inquired if the rovers that attended class got paid and the Director stated they did. He also inquired if we had heard anything more from Miami Township regarding using their fire station as a polling location. Mr. Combs responded that they indicated verbally would keep certain administrative areas away from the public, Chairman Lembke added that we need to confirm with them.

Mr. Conrad also inquired about the cost of the mail house. Deputy Director Dennison is currently working on a spreadsheet. Chairman Lembke added that the postal system was slow is delivering the ballots, are we sure that the mail house did not add any delay mailing the ballots. 
