VI. Board to Reconvene at 5:00 pm (*amended to 4:30 pm*) to Review Additional Absentee Ballots

The board reconvened at 4:46 p.m. Assistant County Prosecutors Brian Shrive and Julia Carney joined the meeting.

Mr. Shrive indicated that his office had no updates requiring an executive session at this time. He addressed a reported email from the Milford School superintendent outlining spending plans for the proposed bond funds and reminding people to vote; the state auditor would be the appropriate party to handle public concerns related to this matter.

Mr. Combs requested that a representative from the Prosecutor's office attend meetings on a more regular schedule, and asked Mr. Shrive about the extra paperwork required for executive sessions. Mr. Shrive replied that the extra due diligence resulted from the Hicks lawsuit against the County Commissioners, which is being argued at the Ohio Supreme Court; oral arguments are expected in March with a decision tentatively in August 2022.

Board members have visited various polling locations and reported that turnout seems low overall.

The board recessed at 5:00 p.m.

The board reconvened at 5:52 p.m.

Director Hemmer-Haight reported that Barbara Hudson had submitted her resignation effective November 5, 2021 due to personal considerations. Mr. Lembke expressed his understanding of the situation, but conveyed the board's regret at seeing her go. The board asked about candidates for her position. Director Hemmer-Haight noted that we have a potential nonpartisan candidate from the earlier interviews for PEO clerk. The board asked for some time to consider potential replacements.

The board discussed the last-minute PEO cancellations and the possibility of compensating the PEOs who stepped up to fill multiple positions; we would like to reward them for extraordinary service

beyond their assigned duties. Mr. Lembke personally witnessed PEOs literally running between precincts to fill gaps and to help new workers. We need strong incentives for the existing PEOs to return, and to recruit new PEOs; we expect the 2022 primary and general elections to be much busier than today and to require additional PEOs. The board asked Director Hemmer-Haight to review potential options.

VII. Board to Review Absentee Ballots

Director-Hemmer Haight reviewed the UOCAVA ballots that need to be remade. These are all valid email ballots that were received prior to Election Day and require duplication to regular ballot stock so the machine will accept them.

Deputy Director Dennison indicated that there were four blank ballots identified by the DS850. Upon discussion by the board as to why a voter would submit a blank ballot, Director-Hemmer-Haight reminded the board that the voters will still get voting credit for returning their ballot.

Per ORC 3506.21(B)(3), the board has no discretion if the tabulating equipment detects an over-vote. There were 29 of these ballots identified by the DS850 scanner; they will be set aside until the final group of absentee ballots have been run through the DS850 tonight. Then we will reprogram the scanner to process any blank or over-vote ballots so the final tally includes the under-vote and over-vote counts. If a ballot has stray marks in addition to an over-vote, it may be segregated again for a different issue.

The board reviewed a ballot with physical damage, and 14 ballots with unclear or ambiguous marks to determine voter intent.
