We expect the total chargebacks to Bethel-Tate School District to be less than the original estimate because we printed ballots in-house and did not contract with ES&S for Election Night support.

XI. Director's report

A. Referrals to Prosecutor:

Director Carney advised the board of two voters with questionable voting activity in the Special Election.

1. Kasandra Renee Oelker was registered at 258 Plane Street in Bethel and voted on Election Day, May 4th, at the Bethel Community Building. She then changed her address via the SOS online voter registration portal at midnight (12:00 a.m. on May 5, 2021) to 1295 State Route 133 – still a Bethel mailing address, but in the Felicity-Franklin School District. Given the timing of the address change, Director Carney asked the board to consider a prosecutor referral regarding whether Ms. Oelker actually lived in Bethel on Election Day, then moved less than 24 hours after casting her vote. Mr. Conrad asked how we discovered the information. Director Carney explained that the SOS directed counties to process registrations last week in preparation for the Vax-a-Million lottery, although modifications to the voter rolls are normally suspended until election certification is complete. In order to maintain the integrity of the election results, we carefully reviewed any pending changes to voters in the Bethel-Tate School District before processing registrations; we discovered that Ms. Oelker had submitted the online address change less than a day after voting.

2021-62 – Mr. Grant made the motion to refer Kasandra Oelker to the Clermont County Prosecutor for further investigation. Mr. Combs seconded the motion. Upon discussion, Mr. Conrad expressed concern that we might appear to accuse a voter of cheating without sufficient evidence. Chairman Lembke stated that, based on the facts presented to the board, it is possible that a voter who was ineligible voted on the levy. He reminded the board that a referral does not take a position that a voter is cheating or even make a probable cause determination; however, because of the unusual coincidence, it would be imprudent to disregard the information without asking the prosecutor to investigate. 2. James E. Huegel, Jr. is registered at 848 Castlebay Dr. in Pierce Township G. He voted in the November 2020 General Election using that address, and has been registered to vote at that address since 2008. The property had been owned by his parents, and the voter lived there for some time. However, the property was sold to the Fenhoff family, who have been residing there since May 2020. Director Carney spoke to Amy Fenhoff, one of the current residents of that property, who indicated that Mr. Huegel did not live there in November 2020. Further review of our records finds that Mr. Huegel probably resides at 1166 Parkside Drive in Batavia. Mr. Huegel's wife Ashley has been registered at the Parkside Drive address since 2016, and the property was transferred to James Huegel in March, 2015. Based on the property records, he probably moved without ever changing his voter registration and voted at his old polling location on Election Day. He voted in November 2015 and November 2020, with no voting history

between those dates. Since he purchased the Parkside Drive property in March, 2015, he could have voted illegally using the Castlebay address in both 2015 and 2020. Mr. Combs asked how this registration discrepancy was discovered. Director Carney indicated that his name came across her desk due to his father's prior history with the board and with litigation regarding the family's actual school district of residence.

B. Budget

Director Carney distributed a summary of YTD expenses vs the budget to the board for review.

Director Carney also distributed a summary of Ohio House Bill 294, the Ohio Elections Security and Modernization Act. The Ohio Association of Election Officials expects multiple changes to the bill before the legislature actually votes on it.

XII. Deputy Director's report

A. Status of new Board of Elections website

Deputy Director Dennison reported that we have a proposed website contract with Revize that has been reviewed by Assistant Prosecutor Shrive for compliance with Ohio law. Deputy Director Dennison plans to collaborate with Revize on the specifications and web design in June; Revize anticipates a 60-90 day process to transition our current web pages and implement desired functionality. The board inquired about the proposed features of the website, specifically automated inquiries for public records requests and capabilities for candidates to file campaign finance reports electronically. Mr. Combs asked whether we need other bids. Deputy Director Dennison advised that the cost of the five-year contract, detailed during the February board meeting, would be under the multiple-bid threshold requirement. The quote includes a service contract. Revise has a specific support page we would use for update requests; most maintenance requests should be completed within 24-48 hours. Our site will link to the SOS site for campaign finance reporting, and we plan to incorporate the features that Revize has provided to Butler County allowing campaigns to generate absentee voter reports and labels from the site. Mr. Combs stated that he views the proposed website as an improvement for our citizens, and for our staff by saving hours of time providing data to political analysts;

The board asked if the county ISD director had reviewed the security criteria for the website. Director Carney reported that she and Deputy Director Dennison had recently met with the new county ISD director. The county has also hired a new web support person to join the ISD staff soon. Director Carney has recommended that the county adopt the enhanced cybersecurity measures that the SOS has required for all boards of elections. While the county administration has not yet decided to implement the higher security standards countywide, ISD has assisted us in meeting the state requirements.

Deputy Director Dennison asked the board for a motion to approve the contract with Revize. Mr. Grant asked whether the contract could be approved subject to board approval of the website content. Upon discussion, the board would prefer additional clarity on the performance terms of the contract prior to a vote. Mr. Shrive has reviewed the contract as to form and statutory compliance, however he has not provided legal advice as to whether the contract terms are favorable for the county. He and Director Carney will review the contract again, specifically focusing on the latitude written into the contract should Revize not meet our requirements or expected design quality. Given the time required to design, review and implement a new website before the November election cycle, Director Carney recommended a special meeting next week to vote on the proposed contract. Deputy Director Dennison will forward a copy to the board for prior review.

B. Creation of and updates to Board of Elections policies

The SOS Election Official Manual (EOM) directs the board to implement policies for certain specific areas of election administration. Following the EOM directions, Deputy Director Dennison advised the board of his plans to draft and present various policies to the board in future meetings. Director Carney advised the board that since the BOE personnel policy was never officially adopted by this board, we are subject to the county policy by default. The director and deputy director plan to review the BOE personnel policy and present an updated version to the board for approval.
