VIII(A). Contested Voter Registration

Mr. Lembke reported that the board had received a letter from the Moscow village solicitor contesting the residency of Dennis Skeene, who signed the village dissolution petition. When the board receives potentially credible information of this nature, we have a statutory duty to investigate under ORC 3501.11. The board discussed whether to request the backup documentation mentioned in the solicitor's letter prior to scheduling a hearing, at which Mr. Skeene would have an opportunity to present his side. Mr. Shrive explained the separate legal provisions for a citizen challenge or a board investigation. Since this is not a citizen challenge, the statute has no prescribed timeline. Therefore, the board can pursue additional discovery before setting a hearing date, and should give Mr. Skeene sufficient notice and opportunity to respond and/or present evidence and witnesses. Mr. Grant suggested scheduling the hearing immediately prior to the monthly board meeting on June 22nd; allowing time in the interim to issue subpoenas. Also, the 6/22 date would enable Mr. Skeene to update his registration if needed before the July 5th voter registration deadline for the August primary. The board agreed to schedule the hearing on Wednesday, June 22, 2022 at 9:00 a.m. Mr. Shrive indicated that he will reach out to Ms. Supinger, the village solicitor, and that his office will prepare any necessary subpoenas.
