Present: President Keith, Dale Maisel, David Wolf, and Jo Novak. Mayor Hackworth and Ed Westerman were absent. Refer to sign in sheet for others present.

Wolf motioned to accept the minutes of April 28, 2022. Novak 2nd, Maisel 3rd the motion and passed unanimously.

A preliminary plat for Public Avenue Townhomes was presented for consideration and approval. Wes Oller, builder/developer, and Michael Stalzer, PE, were present to discuss the plat and ask and answer questions. Shaffer & Hines, the City Engineer, had provided a review comment letter based on their initial review of the plat.

Mr. Stalzer asked if the City has capacity at the wastewater treatment plant right now for this development along with the two approved subdivisions. He was looking for assurance for Mr. Oller that this development would be able to proceed and not get held up due to a moratorium on development due to lack of plant capacity or inability to construct the plant upgrades. President Keith indicated the Engineer (Mr. Stalzer) would need to confer with Shaffer & Hines, as they have more information regarding the plant capacity.

The Commission reviewed the comment letter from Shaffer & Hines. No other questions or concerns were raised nor were any additional conditions placed on the proposed plat or development. Novak motioned to approve the preliminary plat of Public Avenue Townhomes contingent upon the Engineer addressing the review comments from Shaffer & Hines, dated 5/22/2022, and subsequent reviews to ensure the plat complies with the City of Clever city code. Maisel 2nd the motion and passed unanimously.

Wolf made the motion to adjourn at 7:21 pm. Novak 2nd the motion and passed unanimously.


