#### **MINUTES**

Alderman Dellinger made the motion to approve the minutes of September 19, 2023. Alderman Maisel 2<sup>nd</sup> the motion passed with 4 ayes.

Alderman Dellinger made the motion to approve the minutes of October 3, 2023. Alderman Maisel 2<sup>nd</sup> the motion passed with 4 ayes.

#### **FINANCIALS**

Blake Pace with Decker and DeGood was in attendance to present the 2022-2023 Annual audit. The opinion was "clean". Reserve amounts are above where need to be.

Alderman Dellinger made the motion to able this item until October 24, 2023, at 5:00pm. Alderman McPhail 2<sup>nd</sup> the motion and passed with 4 ayes.

Alderman Maisel made the motion to approve the updated Personnel Policies and Regulation Manul for the employees of the City of Clever. Alderman Jack 2<sup>nd</sup> the motion and passed with vote of Maisel – Aye, Dellinger – Naye, Jack – Aye, McPhail – Aye.

Citizen Linda Eutsler was on the agenda to speak with the Board of Aldermen concerning actions of two of the Alderman and her reasonings to why they needed to resign or be impeached. The notes were not taken verbatim but are just a summary as more discussion was held after Mrs. Eutsler was finished. Mrs. Eutsler brought up information about the state audit in 2020, a petition that went around to have Ronnie Keithley and Kristy Keithley terminated from their positions for lack of education, pay was to much, and the fact they are married. Information was brought up on the misconduct by Alderman Dellinger on her daycare was closed, and to include the allegations of abuse. Mrs. Eutsler informed the Board that with all the evidence provides to show that Ms. Dellinger and Ms. Maisel have been out to get Ronnie and Kristy Keithley and are now using their positions as Aldermen to harass and ultimately terminate two employees, this should be grounds for removal of office by any means necessary.

Kathy Barrett – stated her dislike for what is happening and that losing a long-term employee because they felt threatened by Board members is a shame. The community lost more than an employee but years of knowledge.

Brandon Stokes asked if there was a change/update in the handbook that addressed employees being married. Mayor Hackworth stated that was not addressed in this update.

Kenneth Lambeth – former Fire Chief and worked for Clever Mill stated that the City shot itself in the foot while losing Dozer.

Ben Lile asked Alderman Dellinger if she was happy with Dozer being gone. Alderman Dellinger stated she had no answer for this. Mr. Lile would like to know if she doesn't have that answer how can she sit in the seat as Alderman.

Mark Sandoval inquired on what the city is going to do to rectify the issue with not having certified water employees. Mayor Hackworth informed the citizens that current employee went through the class and will be test to get a water license and then will continue to train and test to complete the certification that our system is required to have. Also, it was mentioned that all employees in the water side have went through or stated that training.

Mark Bacon stated that this doesn't make sense.

Caitlyn Doke asked - Does the City want Charlene to be a representative of the City?

Tara Pachelski (sp) Wants to know why we are letting Charlene represent. Alderman Dellinger stated that the child abuse is false.

Jodi Lile would like to know what is going to be done if they do not resign. Mayor Hackworth could not answer what the further process would be.

Britney Stokes – what happens if Dozer pulls his license. Mayor Hackworth stated that the City will be out of compliance with DNR.

Ron Murphy – why if a license is so important, why are we paying him so little. How much is the fine? And we should pay him more and get him back.

Jane Maloney – Alderman can vote for her to resign, why can't we (citizens)?

SPECIAL MEETING OCTOBER 24, 2023

Mayor Hackworth called the regular meeting to order at 5:00 pm with the reciting of the Pledge of Allegiance. Aldermen present: Maisel, Dellinger, Jack, and McPhail. Refer to sign in sheet for all others present.

#### **ADMINISTRATION**

Board of Alderman discussed the Solid Waste bid proposals with the submitted bidders: GFL/WCA, Republic Services, and Cards. Bidders explained their bids and were asked a few questions.

Alderman Dellinger made the motion to able this item until October 24, 2023, at 5:00pm. Alderman McPhail 2<sup>nd</sup> the motion and passed with 4 ayes.

Jennifer Fagan with Republic Services discussed the issues with the missed service over the last two months and how the reroute affected the entire region that is over 35,000 customers but has got better. Over the last three weeks only three or four calls for missed service. Alderman McPhail is concerned about how they plan to continue services if they cannot now. Service was failing then seemed to improve but concerned it was because of the renewal of the contract.

Citizen Ronnie Floyd asked if the contracts/proposals have been reviewed by the city attorney. Alderman McPhail explained that all that will go through the attorney after the final decision on who the City chooses.

Citizen Linda Eutsler stated that she has not had services for three weeks but has received phone calls stating that her service will run on Monday's that is not even the scheduled day and it still never came.

Alderman Dellinger asked Ms. Fagan if the recycling was lumped in the price or was it optional. Ms. Fagan stated that the price was for everything together since the bid asked for free recycling. This would make this an optional service.

Alderman Dellinger asked Mr. Fitzgerald same questions on the recycling pricing.

Alderman Maisel asked all companies what the plan was for scheduled days. Stating that service in Clever used to be all done in one day and now it is in two. They all stated that they would like to keep the two-day schedule to allow for growth.

Alderman Dellinger asked Mr. Fitzgerald questions on the customer service options that CARDS Holdings, LLC has to offer. Mr. Fitzgerald went on to talk about dispatch and services.

Mr. Murry with GFL was asked the same questions on recycling pricing and customer service. The only concern is that GFL requires 50% participation for recycling.

Alderman Dellinger made the motion to accept the proposal from CARDS Holdings, LLC as the new Solid Waste provider for the City of Clever starting January 1, 2024, through December 31, 2026. Alderman Jack 2<sup>nd</sup> the motion and passed with 4 ayes.

Pierzchalski- Alderman Charlene Dellinger will you resign?

Dellinger- No

Pierzchalski- Alderman Dale Maisel will you resign?

Maisel- No

Eutsler- We are now asking for the council to remove Charlene Dellinger & Dale Maisel.

Mrs. Eutsler provided the board with folders that included all the signatures obtained, police reports on Dellinger, DFS paperwork on Dellinger's business, parent statements on Dellinger's business, Audit Report, and a builder's statement on Maisel.

Eutsler- Mr. Mayor we are asking for you to revoke the 2 Westward Alderman positions.

Maisel- Ms. Eutsler did you read the Audit Report? There were employee bonuses being handed out and there was a purchase of property over value. There was nothing in the audit.

Ronnie Floyd- directed towards Maisel- What about stealing bricks?

Maisel- I regret that. It wasn't my intention to steal. They had been there over a year, and some were broken. 18 of them were taken.

James Wright- There are an awful lot of side bars up there (talking amongst each other). Seems some Aldermen didn't come prepared. There are just way too many side bars.

Mandy Crume- Directed towards Maisel- She was making eye contact and showed some concern. Then directed towards Dellinger- She didn't at all and is being disrespectful.

Hackworth- Would like to hold a special meeting to hold possible impeachment/possible vote of removal. All the information collected tonight needs to be taken to legal for review. The meeting will be an open session. There will be no vote tonight.

McPhail would like time to read Mrs. Eutsler's packet as well.

Special Meeting- Possible impeachment/ possible vote of removal/ Inquiry Discussion to be held December 5th, 2023, at 6:00 pm

Hackworth- We are here for the people and need to do our due diligence.

Crume- Can they save the City money with legal fees if they just step down before the 5th?

Hackworth- Yes, they can step down whenever they choose. They really are not costing the City any more money as the lawyer is on retainer. This is not a stall tactic, just making sure we are doing it right. Directed to Eutsler- Any new documents you obtain please give them to ALL.

Dellinger- I have something to say, bringing up my past shows me just how far I've come, and I think God for helping me. So, thank you for showing me my past.

Floyd- 86 votes last election and we have more on the petition for removal.

Hackworth- Stated again he would love for this big of a turn out for projects and for positive things as well.

Jack directed towards Maisel- Do you align yourself in support with Alderman Dellinger?

Maisel- I don't agree with everything Ms. Dellinger has done. I wouldn't have done it that way. I hope how I vote during Council shows that.

Patsy Bacon- Never have we talked amongst ourselves up there when I was on the board like you all have. Bacon to Dellinger- Have you ever had an employee quit for something you have done?

Dellinger- Your question is vague, but yes, I have had employees quit and I have fired employees, but this has nothing to do with city work and it was such a broad question.

SPECIAL MEETING DECEMBER 5, 2023

Mayor Hackworth called the special meeting to order at 6:00pm with the reciting of the Pledge of Allegiance. Aldermen present: Maisel, Dellinger, Jack, and McPhail. Refer to sign in sheet for all others present.

Mayor Hackworth informed everyone that this was a meeting to discuss the process and possible vote on proceeding with impeachment procedures.

Alderman Dellinger requested to address the Board and the citizens present. Alderman Dellinger passed out a handbook that included "Conduct of Council Meetings" developed by Missouri Municipal League. Alderman Dellinger then proceeded to give a speech on her innocence and how she her life has been. She is wanting an outside investigation on how proof of harassment and proof of why she should be removed from office.

Alderman McPhail answered her question on harassment and investigations.

Mrs. Linda Eutsler spoke to Dellinger's speech.

Jodi Lile addressed the Board of Aldermen with her concerns of Alderman Dellinger remaining in the seat.

Mike Samoorian spoke on his experience with Dellinger as a daycare provider.

City Attorney Patty Shilling was in attendance to speak on the procedures for impeachment. She informed the Board that this meeting was to vote on continuing with the process and start the investigation into the Alderman in question to validate if impeachment is warranted. Mrs. Shilling informed everyone that there are certain laws and case law for this type of event. There has to be cause shown to relate to the office of Alderman itself. Past events, like the daycare, cannot be used in the case of the Alderman position held.

Citizens wanted to know this city business would include the Alderman going out to attach clerk and public works director, which has quit.

Jane Maloney asked how costing the City \$67,000 in an audit was not reason. Linda Eutsler asked if moral turpitude would/could be considered in this investigation and asked why the petitions could be used. Mrs. Shilling informed everyone that petitions are not a legal use of removal in a 4<sup>th</sup> class city.

Mary Lisek asked for the timeline of this investigation. Mrs. Shilling stated that she would get it started as soon as possible but would need to have an assistant to help with it.

Alderman McPhail made the motion to move forward with the proceedings and investigation on impeachment of Alderman Charlene Dellinger. Alderman Dellinger 2<sup>nd</sup> the motion and passed with roll call vote: Maisel – Naye, Dellinger – Aye, Jack – Aye, McPhail – Aye.

Alderman McPhail made the motion to move forward with the proceedings and investigation on impeachment of Alderman Dale Maisel. Alderman Dellinger 2nd the motion and passed with roll call vote: Maisel – Aye, Dellinger – Aye, Jack – Aye, McPhail – Aye.

SPECIAL MEETING DECEMBER 5, 2023

Alderman Jack stated that she feels that the process on Alderman Maisel is not necessary as she admitted some fault on things, but her term is up in April.

Kristy Keithley, City Clerk, asked if she could speak to the Board.

"December 4, 2023

This is my response to Ms. Dellinger's email stating that I did not know my job or knowledge of the Sunshine law after requesting information that she knows is not a Sunshine requestable nor does is fall under open records request. And her requesting that I "go back to training":

The new website has been up and running since November 1, 2023. At no point have we had any feedback from Aldermen nor citizens on any of the forms or links that are on it. I would have expected someone to get with us and let us know that they found something that they would have liked to have changed. This was an easy fix but just for everyone's information, you will now receive an email after you submit your request on "Sunshine Request" form.

I have Sunshine training every year. I am well versed in this law and what can and cannot be done with requests. Per the Sunshine Law all requests and the requesters information are open record. This will fall under the City Hall correspondence. I feel that some of the requests that I am getting from Ms. Dellinger could cause issues with employees, past employees, and legal. With that in mind, I do feel that the whole Board needs to be aware of what is going on. Also, with the fact that even in the email that was just sent my integrity, intelligence, and my job skills are being questioned.

Requests can continue to come into the clerk's office in any format and I, as the clerk, will continue to respond to them as the law requires me to. I have never broken the Sunshine Law, nor do I ever intend to. I have always spoken to the City's attorney or Missouri Attorney General's office before responding to any request that I was not fully confident in.

I have never made any comments to you, Ms. Dellinger, that I would not give you any information that you are requesting that I am legally able to give you. As for your last request on the exit interview for Mr. Keithley, legal told me not to email that out. Any Alderman is welcome to come and look at it, but it cannot leave the clerk's office, nor can it be copied to leave the office.

I cannot speak for the "city" as what they are expecting from you. I am only expecting to be treated with the same respect that you give other departments. I am going to put this out one more, final time. I do not appreciate Alderman treating half the city with disrespect that they do not deserve. We have employees that come to work everyday to give this city everything they have to their jobs to just feel unwanted and disrespected by half the Aldermen that are supposed to be here to give guidance and support. When/If they are approached by these specific Alderman they are treated with discontent and as if they are being interrogated. A comment was made about having a personal relationship with an employee in the police department they feel it is ok to go in there are visit with them for unlimited time. Funny how those personal relationships are ok, but Mr. Keithley was questioned when he went to save a life or to even help to pick up an elderly citizen. This is ok? I am guessing a lot of people would be

confused on how this is ok? I know what some of you have said behind our backs. I held my head up high with a smile on my face. I cannot do this anymore.

I will no longer be the City Clerk, Finance Director, Court Administrator, Planning & Zoning Administrator, and/or whatever else I have been for the City of Clever. I am resigning my positions with the City. It is sad that I have lived my life for God and He has led me to love this community to some of the expense of my family and health. I will no longer be doing this. My health and family are coming first from now on.

There is in no way that Ms. Dellinger nor Ms. Maisel have the betterment of this city at the forefront of being an Alderman and have stepped in with the personal agenda. This has been very clear over the last five years of dealing with them. I will say that Ms. Maisel at least kept an open mind once she got into the office of Mayor. Not once has Ms. Dellinger come to my office to discuss projects that are going on. Not once has she inquired about what I do all day (to me at least). Ms. Dellinger wants to sit in the council chamber and judge others but will never find a fault in herself. I learned along the way that that when things are not going well to look at yourself first before you blame others. As we have seen with Dellinger and Maisel, they have no faults and everyone else is to blame.

I have come to grips with this whole situation. I have made mistakes that I have admitted to, but I have never in all my time done something illegal, stolen, or hid anything. I have been put through everything imaginable here, called names, and been accused of just absolute bull. I don't know why I have stayed this long other than I love this City and its residents. I know the citizens will stand strong and not reelect what I feel is a disgrace to the City of Clever. I do not know what Dozer, or I have done to Ms. Dellinger or Ms. Maisel to make them feel so threatened by us that they have personally attacked us. I like to believe that it is the fact that people have confidence and respect for us in our jobs and how we live our lives. I do believe that their own confidence feels threatened by our knowledge that has come from years of experience. They say knowledge is power and they want us to have none of it. I truly feel sorry for them.

To the honorable Mayor Hackworth, two courageous Board Members Mr. McPhail and Ms. Jack, and citizens of Clever. It has been a pleasure to serve you. I have amazing staff that will continue to work as hard as ever if they are treated with respect. I do hope the City officials, supervisors, and employees can work together to make this City as great as is once was and as great as I know it deserves to be. I will miss working for each and every one of you, but I will not miss the stress that should not have been included with this occupation."

Alderman Dellinger made the motion to adjourn at 7:03pm. Alderman McPhail 2<sup>nd</sup> the motion and passed with 4 ayes.

To the Board of Alderman,

For the purposes of section 81.030 RSMo please consider this letter a written request to conduct a census of the City of Clever. My request can either be fulfilled by ordering a census under section 81.030 or section 71.160 RSMo. The former will place the duty of conducting the census in the hands of the Chief of Police pursuant to section 79.050 RSMo's delegation of City Marshal duties in cities that have opted to appoint a Chief of Police. The ladder would be conducted by a Census Supervisor who would be appointed by the Governor.

If the board fails or refuses to pass an ordinance for the taking of a census, when requested in writing to do so, a petition may be presented to the Board of Aldermen signed by not less than twenty-five resident citizens of the city to conduct a section 81.030 census. If the board subsequently fails or refuses to pass an ordinance for taking of the census within thirty days from the date of filing said petition with the city clerk, the Mayor would then, by proclamation, order the Chief of Police to take the census of the city, and when taken by the Chief of Police, under the proclamation of the Mayor, it would have the same force and effect in law as if taken under an ordinance passed by the Board of Aldermen.

Any person failing or refusing to comply with section 81.030 RSMo, could be deemed guilty of a misdemeanor, and could be punished by fine not less than ten dollars or more than one hundred dollars, and could be ousted from office. It also has the possibility to open the city up to civil litigation.
