Plans are required for all building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act No. 299 of the Public Acts of 1980, as amended, and shall bear that architect's or engineer's signature and seal, except:

1. Alterations and repair work determined by the electrical inspector to be of a minor nature.
2. A building of use group R-3 or R-4 containing no more than 3,500 sq. ft. of building area.
3. Wiring or alteration to an electrical system that is greater than 400 amps, unless requested by administrative authority.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.

PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED

GENERAL: Electrical work shall not be started until the application for a permit has been filled with the Building Department. All installation shall be in conformance with the state electrical code. **No work shall be concealed until it has been inspected.**

REFUNDS: Requests for refunds must be made within one year of the date of issuance of a permit unless specifically approved otherwise by the Director of Building Services and shall be subject to deduction as follows:

CANCELLATIONS: A minimum of \$75.00 administrative fee shall be deducted to cover the cost of overhead. If any inspections have been made prior to cancellation of permit an amount equal to the inspection fee for such inspection shall be deducted. Review fees are non-refundable.

WORK STARTED WITHOUT A PERMIT: In the event work is started prior to obtaining approval of a permit application, a supplemental **fee of \$75.00** will be added to the permit fee. If violations are cited or access is denied, a re-inspection fee shall be charged. All fees shall be paid prior to a Certificate of Occupancy being issued.

EXPIRED PERMITS: Permits that have expired after six (6) months will be re-issued one time at a fee of \$75.00. After that a new permit application must be submitted at full price. A cancelled permit cannot be reinstated.

CONTRACTORS: Must show proof of State of Michigan license and register the license with the Village of Clinton.

ALL FEES: Pursuant to the above shall be paid in advance when an application is submitted to the Village of Clinton.

LICENSEE

Section 23a of the State Construction Code Act of 1972, Act No. 230 of the Public Acts of 1972, being Section 125.1523a of the Michigan Compiled Laws, prohibits a person from circumventing the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of this section 23a are subject to civil fines. As the contractor I will cooperate with the Building Inspector and assume the responsibility to arrange for necessary inspections.
