On 09/07/2020 a homicide occurred in the 3500blk of 37th Avenue. The victim was Franklin Vasquez of Colmar Manor. The incident was investigated by Prince George's County police. Gerald Day of Washington DC was arrested and charged within 24 hours of the incident. Colmar Manor police officers assisted with the investigation and played an important role in the quick closure.

At the September meeting of the Mayor & Council purchase of body worn cameras for use by the police officers was approved. The equipment has been purchased and is in use by all of our officers. The Town's insurer, Local Government Insurance Trust (LGIT), provided a grant which covered 50% of the purchase price.

The Port Town's Shopping Center at Colmar Manor recently made a donation to the Town. A portion of the donation was used to purchase schools supplies to assist students with their virtual learning experience. School supplies were provided to 29 families (75 students).

Due to COVID-19, trick-or-treating this Halloween is NOT recommended. The Town is working to plan alternative Halloween fun . . . details to be announced soon.

The COVID-19 Health Emergency has brought many changes including cancellation of most activities and reducing direct contact with the public. People have been dramatically impacted and may need assistance. We have assisted with food distribution at Town Hall and with deliveries to households when needed. CODE COMPLIANCE MONTHLY REPORT

THE FOLLOWING REFLECT THE ACTIVITY OF THE CODE COMPLIANCE OFFICE FOR THE MONTH OF September 2020

The following complaints / observations were addressed:

- 24 high grass notices issued
- 2 trash / bulk / recycle warning notices issued
- 2 warnings issued re abandoned vehicles

Code Enforcement has also been working to identify residences placing their recyclables curbside in plastic bags. Plastic bags inhibit the processing of the recyclables and are prohibited. Town Ordinance O-4-2019 prohibits plastic bags as part of recycling whether inside or outside the recycling bin and provides for a \$50 fine for violation of the ordinance.

Monday	Household Trash	Regular Trash is collected each Monday. Trash should be placed curbside in supplied containers by 6:00 am (but not before 7:00 pm the day before).
	Yard Waste	Yard waste is also collected on Mondays. Please place yard waste curbside in brown paper yard waste bags (NO PLASTIC BAGS) or in a reusable container marked with an 'X'.
Wednesday	Bulk Trash	Bulk Trash is collected each Wednesday after 6am by appointment only. Call 301-773-2069 for an appointment before 2pm Tuesday. Bulk Trash should be placed curbside by 6:00 am (but not before 7:00 pm the day before).
Friday	Recyclables	Recyclable waste is also collected on Fridays. Please have recyclable waste curbside in the container provided by 6:00 am (but not before 7:00 pm the day before) – NO PLASTIC BAGS
