12-15-23	3:06 PM	9900 block 58 th Street	Identity Theft	The victim reported that their debit card information was used to make a fraudulent ATM withdrawal at 5330 S. LaGrange Road at 1:35 PM on the day of the report. The victim was in possession of all of the debit cards related to the account and never shared their PIN number with anyone. Video footage from 5330 S. LaGrange Road shows the offender to be a male white wearing all black clothing and a hat.
12-16-23	7:06 AM	LaGrange Road and Joliet Road	Battery	The victim and offender were both passengers on a Pace Bus. The offender was engaged in a heated dispute with the bus driver when the victim spoke up to intervene. When the victim spoke up, the offender pushed him. The victim declined to prosecute the offender.
12-18-23	4:20 PM	55 th Street and Brainard Avenue	Hit and Run	The victim reported that a semi-truck made a wide turn at the intersection and struck the victim's vehicle which was stopped in traffic. The semi-truck left the scene south on Brainard Avenue. The responding officer checked local businesses for video footage of the truck, but was unable to locate any cameras which captured the incident.
12-18-23	10:38 PM	917 55 th Street, Kenny's	Minor Present a Fake ID	An employee checking identification at the door to the business observed that he was handed a fake ID from a subject attempting to gain entry to the bar. The employee confiscated the ID and contacted police. The offender left prior to the arrival of officers. The investigating officer was able to positively identify and locate the offender the following day to issue a local ordinance citation.
12-20-23	6:16 PM	5555 S. Brainard, TJ Maxx	Hit and Run	The victim parked their vehicle in the parking lot of TJ Maxx at approximately 5:00 PM. When they returned to their vehicle at approximately 6:15 PM they observed damage to their bumper, drivers side taillight, and rear quarter panel from another vehicle hitting the victim's car.
12-20-23	7:26 PM	6400 block Joliet Road	Hit and Run	The victims were rear ended by another car while driving on Joliet Road. The offending driver fled the scene on foot running north on Clocktower Drive. A search of the area was conducted with the assistance of surrounding police departments and a drone, however the offending driver was not located.
