6-2-23	2:58 PM	5555 Brainard Avenue, TJ Maxx	Theft	The victim reported that she was shopping when she was approached by a female black wearing a white shirt and white skirt. The suspect placed articles of clothing on the victim's cart on top of the victim's purse and began asking the victim questions. When the suspect walked away, the victim discovered her wallet missing from the purse. When the victim contacted her bank to advise them a debit card inside the wallet had been taken, they advised the victim that the card had been used at a nearby gas station. Surveillance video showed the person using the card to be a female black approximately 5ft 9in with a thin build wearing a white shirt and white skirt.
6-2-23	11:03 PM	5611 LaGrange Road, Taco Bell	Forgery	Employees of the business reported that on multiple occasions two (2) offenders passed counterfeit 20 dollar bills when making purchases. One of the offenders and the suspect vehicle were identified, however the business declined to prosecute.
6-3-23	10:15 AM	11 Countryside Plaza, Best Buy	Theft	An employee of the business reported that a male black with shoulder length braids, eyeglasses, a black shirt, tan pants, and white shoes attempted to return \$1,069.67 worth of merchandise which had previously been purchased with a stolen credit card. While on scene the employee reported that the offender had previously completed a return of \$952.48 worth of stolen merchandise on 5-19-23.
6-5-23	3:53 PM	6001 LaGrange Road, Starbucks	Battery	The victim reported that a male, described as possibly of middle eastern descent, approximately 5ft 8in with a slim build, brown curly hair wearing 'nice' clothing began a conversation with her. As she repeatedly declined his advances he made unwanted physical contact with her hands. The offender eventually walked away and left the area.
