Crook County Public Health Officials have been notified of 4 laboratory confirmed Covid-19 Cases, 2 probable cases, and 0 deaths May 27 – June 2, 2021. Two cases were delayed reporting from out of state and had already recovered.

CASES REPORTED

2 males 4 females

Places of residence include all areas of Crook County.

THIS CURRENTLY BRINGS CROOK COUNTY TO 447 TOTAL COVID-19 LAB AND PROBABLE CASES

- Active Cases: 6
- Total Recovered: 429
- Covid-19 related deaths: 12
- Vaccines administered in Crook County: CCPH = 1,276 1st doses, 1,116 2nd doses / CCMSD = 60 1st doses, 60 2nd doses
 - Ages 18+ who want a vaccination, please call public health to be scheduled.

Please follow these processes if you have tested positive for Covid-19, or if you have been exposed to a positive Covid-19 case: If you are a close contact to someone who tested positive to Covid-19 when they have symptoms, or during the 48 hours (2 days) before they develop symptoms, you could become infected. Close contact includes:

- Living in the same household as a sick person with Covid-19
- Caring for a sick person with Covid-19
- Being within 6 feet of a sick person with Covid-19 for 15 cumulative minutes or longer, OR
- Being in direct contact with respiratory droplets from a sick person with Covid-19 (e.g., being coughed or sneezed on, sharing utensils)

If you have been exposed, by this criterion, you should quarantine for 10 - 14 days, unless you have been vaccinated. This means you need to stay in your home, not go to work or school and not go out in public or have any visitors in your home. You may need to contact the grocery store or a friend to drop off groceries or supplies to your doorstep. If you develop symptoms during that time, seek medical attention.

If you have tested positive for Covid-19, you need to isolate in your home and away from family members as much as possible. You should follow the same guidelines listed above, for 10 days from the beginning of symptoms, or from the day the positive test was collected if you are without symptoms. You may leave only to seek medical care or to spend time outside on your property. You should isolate yourself as much as possible from non-symptomatic persons living in the home.
