# Implementation Process

Definition for CHIP: Community Health Improvement Plan (CHIP) - A long- term, systematic plan to address issues identified in the Community Health Assessment (CHA) every 5 years. Implementation of the CHIP is tracked and the plan is revised, as needed.

Purpose: A liaison with the community stakeholders and partners will work together to improve the health of the Dawson County residents. The community stakeholders and Dawson County Health Department (DCHD) use the CHIP to set priorities, direct the use of resources, and develop and implement projects, programs, and policies. The implementation process is community-driven as a collaborative planning process that includes significant involvement by a variety of community sectors.

# Background

Methodology: Dawson County Health Department completed the CHA based on the CASPER survey done on April 16-17<sup>th</sup>, 2021. The results of the CASPER survey were used in our meetings with the Stakeholders. DCHD had these meetings on June 28, 2021 and March 28, 2022 going over what topics/issues to be achieved in 5 years by determining 3 focus areas.

# **Prioritizing Community Health Needs**

The implementation planning committee aka stakeholders went through the CHA and reviewed what the community identified as problems. The committee came up with 3 community health needs that also address the identified problem areas.

Lessons learned from the stakeholder meeting on March 28, 2022 to identify 3 focus areas.

- Early Childhood Resource Guide Information would be nice to have all information in one place so the community can know what is available.
- Dawson County Resources Guide is a powerful tool but can be hard to access because people are not aware of it. By creating QR codes this will allow business to place on windows or other access places anyone can scan.
- Social Media Email Group would work with business and stakeholders to promote preventions/activities on social media that everyone can benefit by sharing.

### Services Dawson County Health Department Provides

- Provides Immunizations to adults and children, Family Planning, Women, Infants and Children (WIC), Parents as Teachers, Blood Pressure Clinics and Labs, Home Health Services, Tobacco Prevention, Public Health Emergency Preparedness and Walk-In Services.
- Dawson County Health Department does bill insurance with a low or no cost co-pay.
