Standard Audit Contract Amendment-Olness & Associates, PC-A motion was made to approve the Audit Contract amendment made by auditing firm Olness & Associates PC for the audit period of July 1, 2020 to June 30, 2021 amending the audit amount for FY21 from for increased hours from \$19,400 to \$23,150. The motion was seconded. All voted in favor. Motion carried.

5)Cullinan-Derrick Motel Cullinan Family-Derrick Motel- Members of the Cullinan family were present to update the Commissioners and Sanitarian on their efforts to address the public nuisance complaint on their Derrick Motel property. John Cullinan stated that they have been working with the Sanitarian and the city to clean up the property. They have had three contractors look at it and another they have contacted and should hear back from. They have been in contact with the EPA and did a walk through with an inspector from Miles City. The inspector seemed impressed with the lack of asbestos and on initial walk through felt it was only in some linoleum that was not throughout the building. The dilemma is in the fact the city can only accept so much at the dump at a time. They would have to be in daily contact as to how many loads they would take a day, which could be one or five and change daily. The costs are too high to keep an excavator and workers on site over an extended period of time. The longer it takes, the more it costs. They have looked at different ways of tearing it down including doing it in phases. They would really like to burn it down. They are aware they may need to separate the shingles to burn it. They are moving forward and they understand it needs to be on their dime and should not fall on the taxpayers. They've had offers to remove the lumber, but not deal with any of the rest of the debris. Commissioner Sharbono asked what they are asking of them to do? He stated they are wondering if there is any way that they can get a special permit to burn the building. The sanitarian stated he has been studying the issue, but believes that DEQ does not allow any "construction sites" to be burned or buried unless at a permitted landfill. The Commissioners and the Sanitarian agreed they would research the options further. The Cullinans stated they are scheduled to meet with the city on the 9th and reiterated that no one wants to bid the project without knowing what the city dump will accept in a day. They don't want to string this out. They are aware there is no easy answer and they aren't asking for a handout, but would like to see if there can't be some exception or accommodations made. With the recent fire at the Ponderosa building and other dilapidated buildings this has to be an issue for others besides themselves and other counties and cities. The Sanitarian stated this was driven by a complaint that was filed and he would reach out and see if there is any allowance for a variance. The commissioners stated they would do what they could to help.

Public Information Airport Road-The commissioners noted that the received information that the State Highway Department road is using some safety grant funding to do tree removal on Airport Road. There will be signage and one lane will remain open, but they wanted to make the public aware that this will be happening shortly. The work is to be completed by April 15th.

Airport Road Tree Removal 12) K-9 Program Additional Costs K-9 Program- Additional Costs- Commissioner Sharbono asked the Sheriff to share the information in regards to the additional costs for the K-9 program that were being requested. Sheriff Canen stated that the Deputy leaves on Friday for Pennsylvania to meet the dog and trainer that he will be bringing home. He stated that they learned later that the program recommends that the officer housing the dog be compensated an additional \$500 a month for the training that occurs during off duty time. The dog is expected to have a life duty of 5-7 years. They received donations of \$100,000 plus for the cost of the dog and the training it has received. Another county has loaned them a vehicle that is outfitted for a dog to bring it home with. They have a vehicle and it is in the state now, but due to delays it is still being outfitted with the proper equipment. The commissioners asked if they would be able to do fundraising for the additional \$6,000/year of unanticipated costs not budgeted for. Canen stated that they possibly could. They recently had a large drug forfeiture that may be a source of revenue, but it has to go through the courts and can take up to a couple of years to receive, but they could possibly designate some forfeiture funds to this. He thought he could cover the rest of the fiscal year through his current budget, but it would need to be added to the following years. The commissioners asked if the dog would be used by the city or other counties. Canen stated that they could probably do an assist of once a week for the city, but if it became more frequent they would need to do a memorandum of understanding with the City. Recently they had a request from another county for an assist on a missing person and if they have the dog, that is case they would use the dog for assistance. They would help as they could when called for assistance. A motion was made to approve an additional \$500 a month pay for Deputy Patterson for Canine Care/Training with the department using possible fundraising and forfeitures to help offset the costs. The motion was seconded. All voted in favor. Motion carried.
