The project consists of the secondary phases to a wood constructed 3 story apartment building. The first phase of the project consisted of Level 1 Alterations which included re-cladding and repainting the exterior as well as replacing light fixtures and enhancing portions of accessibility in preparation for phase 2. The scope of work documented for Phase 2; proposes interior reconfiguration of an existing 3 bedroom unit which are categorized as a Level 2 alteration as well as exterior site elements including but not limited to the following; re-striping the parking lot, new trash enclosure, new exterior community patio, and new screen wall to shield mechanical and existing exterior wood stair. With exception to the exterior Patio; there is no proposed expansion of the building footprint. The interior renovations are limited to the 1st level of the Existing addition which is located at the north end of the existing structure. The proposal converts this space to be utilized as a community room for residents. Phase 1 alterations allowed us to gain an accessible entry to this space via the ramp. Once in the space; the residents will have accessible access to the Community Area, Exterior Patio, and Wellness Areas with service functions being limited to restrooms, a package delivery room; mechanical and storage spaces There is no proposed service function of the space and it is to be limited to the general use of the residents and their guests.
