HSB 24-25	3	<p><u>APPROVING CONSENT AGENDA</u></p> <p>Approving the Consent Agenda for items 4-6, for November 20, 2024. Items covered in the Consent Agenda Items are: Minutes from the October 16, 2024 HSB Meeting, Director's Report, and Housing Services Staff Reports which covered: Public Housing Occupancy Report, Section 8 Utilization Report, Supportive Services Team Reports and HCA Quarterly Reports. Receive and File packets.</p> <p>Mr. Johansen informed the board that the Disposition Program is in the final stages of the sale of five homes and anticipate the sale of 7 other</p>

homes in Spring 2025. SEMAP (Section 8 Management Assessment Program) certification was submitted to HUD (Department of Housing and Urban Development) and HUD notified Housing that they received a score of 100%. Housing is currently only issuing vouchers for special programs, like VASH (Veterans Administration Supportive Housing Program). SAFMR (Small Area Fair Market Rent) and an anticipated increase in the cost per voucher were discussed.
