THE REQUIRED LICENSE FEE SHALL BE PAID ACCORDING TO THE APPLICABLE RATE ON OR BEFORE THE 30TH DAY OF APRIL IN EACH YEAR. TO AVOID A LATE PENALTY OF 5% (PER MONTH) OF THE UNPAID FEE SHOULD BE PAID IN FULL BEFORE THE 20TH DAY OF MAY IN EACH YEAR. *THE GROSS INCOME FOR BUSINESS LICENSE PURPOSES MAY BE VERIFIED BY INSPECTION OF RETURNS/REPORTS FILED WITH THE INTERNAL REVENUE SERVICE, SOUTH CAROLINA DEPT. OF REVENUE, SOUTH CAROLINA INSURANCE COMMISSION, OR ANY OTHER GOVERNMENT AGENCY. *THE ISSUANCE OF A BUSINESS LICENSE IS CONDITIONED UPON STRICT COMPLIANCE WITH THE ORDINANCES OF THE CITY OF EASLEY AND FAILURE TO COMPLY MAY RESULT IN REVOCATION OF LICENSE AND POSSIBLE MONETARY FINES.
