No fee may be charged for any services rendered to a defendant or defendant's attorney in any criminal case or in habeas corpus proceedings.

**NRS 19.035 Fees not to be charged or collected for services rendered certain governments or officers.** Notwithstanding any other provision of this chapter, the clerk of the court shall neither charge nor collect any fee for any service rendered by the clerk of the court to:

1. The State of Nevada;
2. The county in which he or she is clerk of the court;
3. Any city or town within that county;
4. The school district of that county;
5. Any general improvement district which is located within that county; or
6. Any officer of the State, that county or any such city, town, school district or general improvement district in the officer's official capacity.
