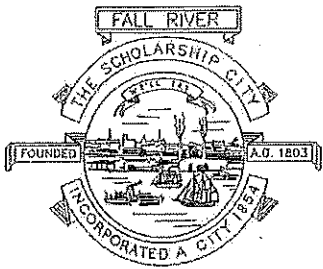
ORDERS – HEARINGS

The City Clerk read the restrictions recommended by the Zoning Board of Appeals, based on the variance that was issued for this business, and stated that the order could be amended to include the following recommendations:
 - No unregistered vehicles to be stored on premises
 - All work to be performed inside of the existing structure and no work to be performed outside of the existing structure
 - Work to be limited to auto repair/service and no auto body work to be performed
 - Hours of operation to be limited to Monday-Friday 8:00 a.m. to 5:00 p.m.
Saturday 8:00 a.m. to noon
 - Any vehicles parked outside of the repair bays to be parked south of the convenience store portion of the existing structure,

On a motion made by Councilor Raymond A. Mitchell and seconded by Councilor Linda M. Pereira, it was unanimously voted to adopt the order, as amended, with the recommended restrictions, with Councilors Richard Cabeceiras and Pam Laliberte-Lebeau absent and not voting.
