Street opening request for pavement less than 5 years old

There has been a request for installation of a gas service at 1147 Plymouth Avenue, by a representative of the owner.

Option One:

This area is one of the sections of Plymouth Avenue that has had extensive reconstruction including full depth pavement, curbing, sidewalks, greenways and pavement markings. Based on the extensive improvements that were completed within the past year and in the highly traveled nature of this roadway, I would recommend denial of this street opening and suggest that the owner investigate alternative routes for the gas service or alternative heating/cooking methods.

Option Two:

If the Council is inclined to allow this street opening, then it is my recommendation that the owner bear all the costs of the following:

- Control density fill used as required by ordinance
- Mill and overlay a 50' longitudinal section of the roadway that is affected from curb line to curb line
- Crack seal all edges
- Replace pavement marking with like kind
- Private firm of the City's choosing to inspect all work
- Be held responsible for pavement for a 10 year period by surety

Option Three:

If the council allows this street opening the requirements should be a minimum of:

- 1. Trench repair work shall be done by a licensed drain layer within the City of Fall River.
- 2. All work is to follow the "Standards Employed by the Public Utility Operators When Restoring Municipal Streets" as published by the Commonwealth of Massachusetts Division of Telecommunications and Industry and with the requirements of the Fall River City Council.
- 3. The engineering division shall be notified prior to excavation in order to assure city inspection of this work.
- 4. An infrared patch will be used for repair of the asphalt surface.

Option One is recommended.



The chair called the meeting to order at 5:32 p.m. and announced that the meeting may be recorded with audio or video and transmitted through any medium.

Agenda:

1. Resolution – Educational presentation by Seven Hills Behavioral Health regarding NARCAN

The Director of Community Health Services of Seven Hills Behavioral Health made an educational presentation and demonstration on how to use and administer NARCAN, an opiate blocker. Due to the lacing of fentanyl in heroin, the Department of Public Health is providing a stronger NARCAN carried by first responders. Mrs. Rocha Mimoso also provided an overview of the program she administers, which includes being the NARCAN pilot program for the Commonwealth of Massachusetts for 11 years and having a network of outreach workers who interact with all parties affected by the use of drugs. Mrs. Rocha Mimoso explained that the administering of NARCAN is also a tool used to engage users and provide them with the information and resources available so they can get treatment and reduce the stigma. On a motion made and seconded, it was unanimously voted to recommend that the resolution be granted leave to withdraw.

2. Resolution – Discuss opioid epidemic and potential ways to mitigate its negative effect on the community

Councilor Pam Laliberte-Lebeau welcomed all parties and stated that she was touched by the Opiate Awareness Day held recently. Chief Daniel Racine and Captain Joseph Cabral of the Fall River Police Department reviewed the statistics for overdoes and deaths resulting from overdoses. To date, there have been 644 overdoses in the year 2016. There has been an increase in overdoses and reported overdoses because of the outreach work of agencies such as Seven Hills Behavioral Health that has helped remove the stigma and as a result people are not as afraid to call 911 for help. In addition, a state law signed in July of 2016 allows drug users to place themselves in protective custody and allows Police Departments to place them in protective custody. Nancy Paull, CEO of Stanley Street Treatment and Resources, Inc. (SSTAR) made a presentation focusing on drug dependence as a disease, reviewed how Fall River is in the midst of an opioid epidemic and how the continuum of care model, which includes Promotion, Prevention, Treatment and Recovery, could lead to an effective management of drug dependence. SSTAR has been chosen as 1 of 28 agencies worldwide to be represented in the United Nations on this matter. She stated that although Fall River is in the midst of an opioid epidemic, implementation of federal programs already in place similar to that of tobacco and AIDS would prove successful. However, due to the stigma, the amount of funding spent is very little in comparison to other diseases. There is also a large need for beds and as a result SSTAR was chosen as one of the three Triage Centers being built in the Commonwealth to provide more beds and services. Councilor Cliff Ponte stated he would reach out to the Superintend to work with SSTAR on a school curriculum focused on prevention. Laura Ferreira Washington of the BOLD Coalition outlined the drug free activities BOLD promotes such as the ColorRun, the Prescription Monitoring Program, and roundtable discussions and partnerships with local, state and federal stakeholders as ways to prevent drug use and the collection of data to allow them to apply for public and private grants that fund their mission. One such partnership led to the City's first Opioid Awareness Day. Councilor Richard Cabeceiras stated that the continuum of care model is the best strategy, that he was impressed with the work done for Opioid Awareness Day and that the collection of data and interdepartmental collaboration is key. Kevin Doyle, Director of River 2 Recovery, stated his agency has been open for 20 months and is looking to be a resource to drug dependents informing them of services, where beds are available and providing transportation. Currently River2Recovery does not receive any funding. Mr. Doyle funds the agency out of his own pocket. Karen A. Long, Nursing Supervisor, for the Fall River Public Schools stated a substance abuse curriculum is being worked on for 6th to 12th grades. A protocol is also in place at all schools for the use of NARCAN to be administered by trained nurses. Stephanie Perry, Emergency Department Addictions Nurse at Saint Anne's Hospital and co-chair of the Substance Abuse Taskforce, helps to run a program started by women with addictions. One of her primary functions is to visit drug dependents bedside. Councilor Cliff Ponte left at 7:40 p.m. Melissa Kachapis, Residential Clinical Director, and Michael Bryant at Steppingstone Inc. stated their agency provides beds for men and women and they always have waitlists and schedule interviews and screenings in advance as a result of the high demand. Beth Fontes, Deputy Director of EMS, stated the Department of Public Health is now allowing a 4mg dose to be administered by firefighters and police officers.

The chairman called the meeting to order at 5:20 p.m. and announced that the meeting may be recorded with audio or video and transmitted through any medium.

Agenda:

1. Order – Joint pole location for Verizon New England Inc. and Massachusetts Electric Company – Newton Street Extension – three poles

The objector met with the Verizon representative and is comfortable with the work being done. On a motion made and seconded, it was unanimously voted to recommend that the order be adopted.

2. Resolution - Pothole epidemic

The Administrator of Public Utilities explained that the water division's trench and sidewalk repair has improved dramatically since the use of flowable fill. In addition, the division has invested excess funds from water main replacement bonds to repair water trenches and pave streets. The sewer division does less trench and pothole repairs because sewer collapses are minimal. He recommends a 20-year paving plan to be coordinated with all utility work as listed in the Master Plan. Councilor Steven A. Camara requested that a single number be made available to report potholes to make it easier for residents. The City Administrator stated that through the Community Compact, a 311 phone and internet based service, to be implemented by June 30, 2017, will include reporting of

constituent services and complaints. Councilor Pam Laliberte-Lebeau requested that a live person be made available as part of this system and the City Administrator stated that a staffing and supervisory assessment would be done to make it possible. The Department of Community Maintenance is in the process of restructuring work crews to be comprised of 2 concrete crews for sidewalks and 2 asphalt crews for potholes and is waiting for the necessary equipment to be purchased through the capital plan. The Sewer Division Project Manager, currently overseeing operations in the Engineering Division on an interim basis, stated that 1,016 street opening permits were issued and inspected in 2015. The Chair stated the gas company couldn't use flowable fill. On a motion made and seconded, it was unanimously voted to table the resolution.

3. Resolution - Discuss quality of pothole patches

On a motion made and seconded, it was unanimously voted to recommend the resolution be granted leave to withdraw.

- 5. East of the intersection of Pleasant and Eighth Streets on Pleasant Street
- 6. Southwest of the intersection of Highland Avenue and Prospect Street on Highland Avenue
- 7. Southwest of the intersection of Prospect and Hanover Streets on Hanover Street
- 8. Northeast of the intersection of Bedford Street and Stonehaven Road on Stonehaven Road
- 9. Northwest of the intersection of North Main and Cherry Streets on Cherry Street
- 10. Southwest of the intersection of Seventeenth and Pleasant Streets on Seventeenth Street
- 11. East of the intersection of Pine and High Streets on Pine Street
- 12. Northeast of the intersection of Graham and Currant Roads on Graham Road
- Northeast of the intersection of Rodman and Lonsdale Streets on Rodman Street
- Northeast of the intersection of Dover and Snell Streets on Dover Street

Mobilitie, LLC representatives explained they provide a hybrid backhaul transport system that allows the moving of data wirelessly to wireless providers. Their current proposal includes 14 locations. Additional locations could be added, including two petitions recently withdrawn, after the permitting process for these locations is complete. Radio frequency reports are produced for each permitted location and poles must meet FCC limits. Mobilitie, LLC is willing to re-work their proposal in terms of height or visual appearance if needed. The Sewer Division Project Manager expressed concerns with the height of the proposed poles, which can range from 45 to 120 feet, double the height of standard poles and does not recommend the Plymouth Avenue and Pleasant Street locations, which have underground utilities. He suggested that private land be used instead of public ways. The Corporation Counsel recently received a draft 25-year agreement and will be working with company representatives and the Administration on details, which could potentially include a \$2,400 payment to the City for each pole. Councilor Pam Laliberte-Lebeau also requested that the Administration and the Corporation Counsel reach out to Providence, RI, since they are also in the process of permitting Mobilitie poles. Councilor Steven A. Camara would like to learn the relationship with other utilities and would prefer a bidding process through requests for proposals (RFPs) to allow for a comparison with other companies. Three objectors came forward. William Texeira stated the proposed pole (item. 15) is outside his bedroom window and is concerned with the pole's height and electromagnetic effects. Councilor Pam Laliberte-Lebeau left at 6:45 p.m. David Motta has a motorcycle repair business on Pleasant Street and has seen many accidents near the proposed location for item 5.

George Mercier stated the same pole would not be a good fit for Pleasant Street because it has underground utilities and he is concerned with the electromagnetic exposure; it would also impede advertising and snow removal at his business. The Corporation Counsel will work on an interim report to the Council, which will include RFP requirements, an Engineering and Health Department review, as well as the impact on Streetscapes. On a motion made and seconded, it was unanimously voted to table items 4 to 17 and send letters to the Administration, the Corporation Counsel and the Director of Health and Human Services to provide guidance on how the Committee should move forward and request that the Director of Health and Human Services research and advise the Committee if these poles would have any electromagnetic effects, with Councilor Pam Laliberte-Lebeau absent and not voting. A copy of such letters is attached hereto and made a part of these minutes.

On a further motion made and seconded, it was unanimously voted to adjourn at 7:09 p.m.




