



WHEREAS, the Grantor is the owner of that public way known as Judge Street, a portion of which are the premises subject to this Easement (the "Burdened Premises"). The Burdened Premises are described in Exhibit A attached hereto and incorporated by reference herein and also shown on a plan attached hereto as Exhibit B; and

The Grantee agrees to indemnify and hold the Grantor harmless from and against all costs, claims, expenses, damages (including personal injury and property damage), and liabilities of any nature whatsoever (including, without limitation, court costs and reasonable attorney's fees), incurred by the Grantor (a) as a result of or in connection with any personal injury or property damage that occurs in, on, or around the Burdened Premises in connection with any exercise of the rights granted to the Grantee hereunder, (b) as a result of or in connection with any failure by the Grantee to comply with the provisions of the instrument, or (c) otherwise resulting from or relating to any exercise of the right granted to the Grantee hereunder, unless such cost, claim, expense, damage or liability is a result of the conduct of the Grantor or the Grantor's agent, employees, invitees or contractors.
- 3. As used herein, the terms "Grantor" and "Grantee" shall include their respective heirs, legal representatives, successors, assigns, and successors in title, and the rights, agreements, and obligations contained herein shall be covenants running with the land and shall be binding upon and inure to the benefit of the parties, hereto and those claiming title to or interest in the Burdened Premises and/or the Benefited Premises.



BE IT ORDAINED, by the City Council of the City of Fall River, Massachusetts, as follows:

That Chapter 10 of the Code of the City of Fall River, Massachusetts, 2018, which chapter relates to Buildings and Building Regulations, be amended, by striking out Sections 10-246, 10-247, and 10-248, in their entirety, and inserting in place thereof, the following:

Sec. 10-246. Floodplain district boundaries and base flood elevation data.

The purposes of the Floodplain District are to:

1) Ensure public safety through reducing the threats to life and personal injury;

2) Eliminate new hazards to emergency response officials;

3) Prevent the occurrence of public emergencies resulting from water quality, contaminations, and pollution due to flooding;

4) Avoid the loss of utility services which if damaged by flooding would disrupt or shut down the utility network and impact regions of the community beyond the site of flooding;

5) Eliminate costs associated with response and cleanup of flooding conditions:

6) Reduce damage to public and private property resulting from flooding waters.

The floodplain district is herein established as an overlay district. The district includes all special flood hazard areas within the City designated as Zone A, AE, AO or VE on Fall River's Flood Insurance Rate Map (FIRM) issued by the Federal Emergency Management Agency (FEMA) for the administration of the National Flood Insurance Program. The map panels of the county FIRM that are wholly or partially within the City are panel numbers 25005C0264F, 25005C0269F, 25005C0342F, 25005C0344F, 25005C0351F, 25005C0353F, and 25005C0432F, dated July 7, 2009; and panel numbers 25005C0244G, 25005C0263G, 25005C0329G, 25005C0331G, 25005C0332G, 25005C0333G, 25005C0334G, 25005C0341G, and 25005C0337G dated July 16, 2014, and 25005C0268G, 25005C0352G, 25005C0354G, 25005C0356G, 25005C0357G, 25005C0358G, 25005C0359G, 25005C0361G, and 25005C0362G dated July, 6, 2021. The exact boundaries of the district

may be defined by the one-hundred-year base flood elevations shown on the FIRM and further defined by the county Flood Insurance Study (FIS) report dated July 6, 2021. The FIRM and FIS report are incorporated herein by reference and are on file with the City Clerk.

### **USE REGULATIONS**

The floodplain district ordinance is part of a federal requirement for communities that choose to participate in the NFIP. However, the state already administers regulations that take care of many floodplain management concerns. Referencing existing regulations is important to ensure that projects have been reviewed under the appropriate state regulations and that variances to the conditions of the ordinance do not erroneously allow variances to state requirements.

The Floodplain District is established as an overlay district to all other districts. All development in the district, including structural and nonstructural activities, whether permitted by right or by special permit must be in compliance with Chapter 131, Section 40 of the Massachusetts General Laws and with the following:

Sections of the Massachusetts state Building Code (780 CMR) which address floodplain and coastal high hazard areas;

Wetlands Protection Regulations, Department of Environmental Protection (DEP) (currently 310 CMR 10.00);

Inland Wetlands Restriction, DEP (currently 310 CMR 13.00);

- Coastal Wetlands Restriction, DEP (currently 310 CMR 12.00); (e communities only)

Minimum Requirements for the Subsurface Disposal of Sanitary Sewage, DEP (currently 310 CMR 15, Title 5);

Any variances from the provisions and requirements of the above referenced state regulations may only be granted in accordance with the required variance procedures of these state regulations.

# Sec. 10-247. Base flood elevation data and floodway data.

- A. In Zones A and AE, along watercourses that have not had a regulatory floodway designated, the best available Federal, State, local, or other floodway data shall be used to prohibit encroachments in floodways which would result in any increase in flood levels within the community during the occurrence of the base flood discharge.
- B. Base flood elevation data is required for subdivision proposals or other developments greater than 50 lots or five acres, whichever is the lesser, within the unnumbered A zones.

Sec. 10-248. Other use regulations.

A. All new construction within zone VE must be located landward of the reach of mean high tide.

B. In a riverine situation, the director of code enforcement shall notify the following agencies of any alteration or relocation of a watercourse:

- (1)Adjacent communities including the towns:
  - a. Tiverton, Rhode Island,
  - b. Somerset, Massachusetts
  - c. Westport, Massachusetts;
  - d. Dartmouth, Massachusetts; and
  - e. Freetown, Massachusetts;
- (2)NFIP State Coordinator, Massachusetts Department of conservation and Recreation, 251 Causeway Street, Suite 600-700, Boston, MA 02114-2104; and
- (3)NFIP Program Specialist, Federal Emergency Management Agency, Region I, 99 High Street, 6th Floor, Boston MA 02110
- C. Man-made alteration of sand dunes within Zone VE which would increase potential flood damage are prohibited.
- D. Within Zone AO on the FIRM, adequate drainage paths must be provided around structures on slopes, to guide floodwaters around and away from proposed structures.
- E. Within Zones AH and AO on the FIRM, adequate drainage paths must be provided around structures on slopes, to guide floodwaters around and away from proposed structures. (c, d, e communities, if AH or AO appear)
- F. All subdivision proposals must be designed to assure that:

(1) Such proposals minimize flood damage;

(2) All public utilities and facilities are located and constructed to minimize or eliminate flood damage; and

(3) Adequate drainage is provided to reduce exposure to flood hazards. (b, c, d, e communities)

Sec. 10-249 Use of FEMA maps and supporting studies.

Abrogation and greater restriction section. The floodplain management regulations found in this Floodplain Overlay District section shall take precedence over any less restrictive conflicting local laws, ordinances or codes.

- B. Disclaimer of liability. The degree of flood protection required by this ordinance is considered reasonable but does not imply total flood protection.
- C. Designation of community Floodplain Administrator. The City of Fall River hereby designates the Inspector of Buildings to be the official floodplain administrator for Fall River.
- D. Requirement to submit new technical data. If Fall River acquires data that changes the base flood elevation in the FEMA mapped Special Flood Hazard Areas, Fall River will, within 6 months, notify FEMA of these changes by submitting the technical or scientific data that supports the change(s). Notification shall be submitted to:

FEMA Region I Risk Analysis Branch Chief 99 High St., 6th floor, Boston, MA 02110

And copy of notification to:

Massachusetts NFIP State Coordinator MA Dept. of Conservation & Recreation, 251 Causeway Street, Boston, MA 02114

E. Variances to building code floodplain standards. Fall River will request from the State Building Code Appeals Board a written and/or audible copy of the portion of the hearing related to the variance, and will maintain this record in the community's files.

Fall River shall also issue a letter to the property owner regarding potential impacts to the annual premiums for the flood insurance policy covering that property, in writing over the signature of a community official that (i) the issuance of a variance to construct a structure below the base flood level will result in increased premium rates for flood insurance up to amounts as high as \$25 for \$100 of insurance coverage and (ii) such construction below the base flood level increases risks to life and property.

Such notification shall be maintained with the record of all variance actions for the referenced development in the floodplain overlay district.

- F. Variances to local Zoning Ordinances related to community compliance with the National Flood Insurance Program (NFIP). A variance from these floodplain ordinances must meet the requirements set out by State law, and may only be granted if: 1) Good and sufficient cause and exceptional non-financial hardship exist; 2) the variance will not result in additional threats to public safety, extraordinary public expense, or fraud or victimization of the public; and 3) the variance is the minimum action necessary to afford relief.
- G. Permits are required for all proposed development in the Floodplain Overlay District. Fall River requires a permit for all proposed construction or other development in the floodplain overlay district, including new construction or changes to existing buildings, placement of manufactured homes, placement of agricultural facilities, fences, sheds, storage facilities or drilling, mining, paving and to other properties.
- H. Assure that all necessary permits are obtained. Fall River's permit review process includes the use of a checklist of all local, state and federal permits that will be necessary in order to carry out the proposed development in the floodplain overlay district. The proponent must acquire all necessary permits, and must submit the completed checklist demonstrating that all necessary permits have been acquired.
- I. Subdivision proposals. All subdivision proposals and development proposals in the floodplain overlay district shall be reviewed to assure that:
  - (a) Such proposals minimize flood damage.
  - (b) Public utilities and facilities are located & constructed so as to Minimize flood damage.
  - (c) Adequate drainage is provided.
- J. Unnumbered A Zones. In A Zones, in the absence of FEMA BFE data and floodway data, the Building Division will obtain, review and reasonably utilize base flood elevation and floodway data available from a Federal, State, or other source as criteria for requiring new construction, substantial improvements, or other development in Zone A as the basis for elevating residential structures to or above base flood level, for flood proofing or elevating nonresidential structures to or above base flood level, and for prohibiting encroachments in floodways.

Recreational vehicles. In A1-30, AH, AE Zones, V1-30, VE, and V K. Zones, all recreational vehicles to be placed on a site must be elevated and anchored in accordance with the zone's regulations for foundation and elevation requirements or be on the site for less than 180 consecutive days or be fully licensed and highway ready.

Section 10-250. Definitions.

DEVELOPMENT means any man-made change to improved or unimproved real estate, including but not limited to building or other structures, mining, dredging, filling, grading, paving, excavation or drilling operations or storage of equipment or materials. [US Code of Federal Regulations, Title 44, Part 59]

FLOODWAY - The channel of the river, creek or other watercourse and the adjacent land areas that must be reserved in order to discharge the base flood without cumulatively increasing the water surface elevation more than a designated height. [Base Code, Chapter 2, Section 202]

FUNCTIONALLY DEPENDENT USE means a use which cannot perform its intended purpose unless it is located or carried out in close proximity to water. The term includes only docking facilities, port facilities that are necessary for the loading and unloading of cargo or passengers, and ship building and ship repair facilities, but does not include long-term storage or related manufacturing facilities. [US Code of Federal Regulations, Title 44, Part 59] Also [Referenced Standard ASCE 24-14]

HIGHEST ADJACENT GRADE means the highest natural elevation of the ground surface prior to construction next to the proposed walls of a structure. [US Code of Federal Regulations, Title 44, Part 59]

HISTORIC STRUCTURE means any structure that is:

(a) Listed individually in the National Register of Historic Places (a listing maintained by the Department of Interior) or preliminarily determined by the Secretary of the Interior as meeting the requirements for individual listing on the National Register;

(b) Certified or preliminarily determined by the Secretary of the Interior as contributing to the historical significance of a registered historic district or a district preliminarily determined by the Secretary to qualify as a registered

historic district:

(c) Individually listed on a state inventory of historic places in states with historic preservation programs which have been approved by the Secretary of the Interior; or

(d) Individually listed on a local inventory of historic places in communities with historic preservation programs that have been certified either:

(1) By an approved state program as determined by the Secretary of the

Interior or

(2) Directly by the Secretary of the Interior in states without approved programs.

[US Code of Federal Regulations, Title 44, Part 59]

NEW CONSTRUCTION - Structures for which the start of construction commenced on or after the effective date of the first floodplain management code, regulation, ordinance, or standard adopted by the authority having jurisdiction, including any subsequent improvements to such structures. New construction includes work determined to be substantial improvement, [Referenced Standard ASCE 24-14]

## RECREATIONAL VEHICLE means a vehicle which is:

(a) Built on a single chassis;

(b) 400 square feet or less when measured at the largest horizontal projection;

(c) Designed to be self-propelled or permanently towable by a light duty

truck: and

(d) Designed primarily not for use as a permanent dwelling but as temporary living quarters for recreational, camping, travel, or seasonal use.

[US Code of Federal Regulations, Title 44, Part 59]

## REGULATORY FLOODWAY - See FLOODWAY.

SPECIAL FLOOD HAZARD AREA - The land area subject to flood hazards and shown on a Flood Insurance Rate Map or other flood hazard map as Zone A, AE, A1-30, A99, AR, AO, AH, V, VO, VE or V1-30. [Base Code, Chapter 2, Section 202]

START OF CONSTRUCTION - The date of issuance for new construction and substantial improvements to existing structures, provided the actual start of construction, repair, reconstruction, rehabilitation, addition, placement or other improvement is within 180 days after the date of issuance. The actual start of construction means the first placement of permanent construction of a building (including a manufactured home) on a site, such as the pouring of a slab or footings, installation of pilings or construction of columns.

Permanent construction does not include land preparation (such as clearing, excavation, grading or filling), the installation of streets or walkways, excavation for a basement, footings, piers or foundations, the erection of temporary forms or the installation of accessory buildings such as garages or sheds not occupied as dwelling units or not part of the main building. For a substantial improvement, the actual "start of construction" means the first alteration of any wall, ceiling, floor or other structural part of a building, whether or not that alteration affects the external dimensions of the building. [Base Code, Chapter 2, Section 202]

STRUCTURE means, for floodplain management purposes, a walled and roofed building, including a gas or liquid storage tank, that is principally above ground, as well as a manufactured home. [US Code of Federal Regulations, Title 44, Part 59]

SUBSTANTIAL REPAIR OF A FOUNDATION – When work to repair or replace a foundation results in the repair or replacement of a portion of the foundation with a perimeter along the base of the foundation that equals or exceeds 50% of the perimeter of the base of the foundation measured in linear feet, or repair or replacement of 50% of the piles, columns or piers of a pile, column or pier supported foundation, the building official shall determine it to be substantial repair of a foundation. Applications determined by the building official to constitute substantial repair of a foundation shall require all existing portions of the entire building or structure to meet the requirements of 780 CMR. [As amended by MA in 9th Edition BC]

VARIANCE means a grant of relief by a community from the terms of a flood plain management regulation. [US Code of Federal Regulations, Title 44, Part 59]

VIOLATION means the failure of a structure or other development to be fully compliant with the community's flood plain management regulations. A structure or other development without the elevation certificate, other certifications, or other evidence of compliance required in §60.3(b)(5), (c)(4), (c)(10), (d)(3), (e)(2), (e)(4), or (e)(5) is presumed to be in violation until such time as that documentation is provided. [US Code of Federal Regulations, Title 44, Part 59]

That Chapter 66 of the Code of the City of Fall River, which chapter relates to Streets, Sidewalks and Other Public Places, be amended by striking out Section 66-258 in its entirety, and Inserting in place thereof the following:

## Sec. 66-258. Permit for signs and other structures projecting into or over public way.

- (a) Required; fee; revocation. No person shall place or maintain any structure, as described in M.G.L. c. 85, § 8, projecting into or placed on or over a public way without first obtaining a permit from the City Council. The fee for the permit shall be as provided in Chapter A110, Fee Schedule of the City Code.
- (b) Exception; outdoor dining. A permit issued by the City Council pursuant to this section shall not be required for structures used for outdoor dining on a public sidewalk or other public way, provided the restaurant/applicant has obtained all city required approvals including, but not limited to, written approval from the City Building Inspector.
- (c) Violations; penalty. The City may immediately remove, at the expense of the owner, any sign or structure found to be in violation of this section. Additionally, any person found to be in violation of this section shall also be subject to a fine, as provided in Section 2-1025. However, pursuant to M.G.L. c. 85 § 8, no fine shall issue unless the person fails to remove the structure or cure the violation after being given five (5) days notice to do so.
- (d) Licensing period. A permit issued under the provisions of this article is revocable and shall be valid for the period of time allowed by the permitting authority.


- It's not clear from the description exactly what this new driveway will look like. It sounds as if he would like all curbing in front of his property to be removed. Why would 16ft of curb need to be removed to create an additional driveway on the south side of the property? Is this a wrap-around driveway? Is it a two-car horizontal or vertical driveway? It would be nice to see a rendering of the proposed change, as it would drastically alter the look of the property and as such, the neighboring area (and property values.)
- Will this removal of curbing affect any of the trees on this side of the street? I would object to any such alteration.
- The notice states that the owner would like to add a two car driveway to alleviate the demand for onstreet parking. I have attached a picture of how this street looked this morning. As you can see, there is ample parking. In the 40+ years that my mother has owned this house, and the 20 years that I have resided here, there has never been an issue with parking on the street. Mr. Medeiors has owned the house for less than a year, and in that time, I have only noticed a parking issue when he was rehabilitating the first floor apartment. After that work was complete, the issue was resolved.

 Committee on Finance convene to discuss plans to improve city parks and baseball fields

The Director of Financial Services provided a brief overview of the matter. She then stated that it would cost approximately \$15,000.00 to maintain the lighting necessary for baseball leagues. Council President Cliff Ponte asked if this was included in the Fiscal Year 2022 Budget. The Director of Financial Services stated that it was not included, but there should be sufficient funds to cover this expense. The Director of Community Maintenance stated that approximately \$8,000.00 is needed for maintenance and repair of the lights. He then stated that he does not anticipate needing this amount annually, once the maintenance is up to date. Councilor Linda M. Pereira stated that she would like to see the restrooms open for residents, but vandalism is always a concern. She then asked how many benches were installed in Father Kelly Park. Nancy Smith stated that 15 benches were installed in Father Kelly Park. Councilor Linda M. Pereira asked if more funds are being allocated to the Park Department. The Director of Financial Services stated that more funds were allocated for expenses and also to hire seasonal workers. Councilor Trott Lee asked what tasks are performed by seasonal workers. The Director of Community Maintenance stated any job that needs to be done in the City parks. Councilor Michelle M. Dionne asked how much do the leagues pay for the use of the parks. Nancy Smith stated that no leagues pay to use the fields. She then stated that some surrounding communities charge fees such as New Bedford, Taunton and Somerset. Councilor Linda M. Pereira asked if the City provides loam for the maintenance of the fields. Nancy Smith stated that her department spends approximately \$15,000.00 per year on loam, lime, ballfield clay and speedy dry. Councilor Shawn E. Cadime stated that he would like to have a Capital Plan including a vision for the parks. He then stated that there may be grant funds available to assist with the project. On a motion made by Councilor Michelle M. Dionne and seconded by Councilor Christopher M. Peckham, it was unanimously voted to amend resolution #3 by adding the following at the end: as well as bring forward, in conjunction with the baseball leagues, and immediate capital needs for our City parks, and

BE IT FURTHER RESOLVED, that bids be obtained and a cost provided to the City Council for a strategic Master Plan for all parks and that it be researched whether Open Space and Recreational grant funding is available for these improvements.

On a further motion made by Councilor Trott Lee and seconded by Councilor Leo O. Pelletier, it was unanimously voted to table both items #2 and #3.

 Committee on Finance meet with Administration to discuss trash collection and proposal for Cart Program

Councilor Pam Laliberte-Lebeau stated that she had spoken with the Mayor and he requested that this matter be tabled to allow the Administration more time to prepare for the discussion. She then stated that she does not have a problem with tabling the matter but would like an answer regarding the end date for the collection of commercial trash and recycling. Councilor Christopher M. Peckham asked if the carts can just be removed from these businesses. The Director of Community Maintenance stated that the City needs to notify these businesses and give them time to locate alternate trash haulers. Councilor Linda M. Pereira stated that there were fees and pay as you throw bags in the City, but these were rescinded due to political pressure. Councilor Trott Lee asked how much notice does the City need to give to these businesses. The Director of Community Maintenance stated that 60 days notice should be provided. He then stated that some of these businesses have apartments located above the business. Councilor Shawn E. Cadime stated that the City Council may need a legal opinion on the definition of "household trash". Councilor Leo O. Pelletier asked how many businesses are having their trash collected. The Director of Community Maintenance stated that there are 110 businesses, with a total of 372 carts that are collected. He also stated that there are 1,983 businesses located in the City and only 110 businesses have solid waste and recycling collected by the City. On a motion made by Councilor Shawn E. Cadime and seconded by Councilor Michelle M. Dionne, it was unanimously voted to send a letter to the Mayor as follows:



Dear Mayor Coogan.

At a meeting of the City Council Committee on Finance held on May 11, 2021, a discussion was held regarding collection of trash for commercial establishments. A motion was made and seconded to request that I review the city ordinances available to me. I have had the opportunity to do so and my thoughts are outlined below.

Sec. 62-1 defines CART as "The City-supplied wheeled trash receptor. Blue and pink carts are solely used for recycling and green carts for household trash.

Further, Section 62-2 outlines Collection and disposal generally. The ordinance states:

C. The City shall collect solid waste and recyclables from single-family dwellings and multiplefamily residential buildings containing up to six dwelling units. Solid waste shall be collected only if placed in an official City bag and placed in a green cart. Recyclables shall not be placed in green carts, and solid waste shall not be placed in blue or pink carts.

In reviewing these sections, it is my opinion that without specific verbiage in which "commercial trash" is collected and since Section 62-2(C) does specify collection for HOUSEHOLD trash, it could be and is implied that collection for commercial establishments does not occur. However, this is currently happening.

ARTICLE II provides for Collection Regulations. Section 62-42 which describes Placement of refuse from commercial establishments on sidewalk states:

Business establishments, stores, restaurants and laundries will be permitted to place refuse and rubbish on the sidewalk on the day of collection, provided such refuse and rubbish shall be in

proper containers and bundles and shall occupy a space not larger than 12 feet long, three feet wide and four feet high.

As the Council Vice President indicated during the meeting, Section 62-42 relates to placement of trash on the city's sidewalks, but does not authorize such collection.

Members of the City Council had a clear message: the 110 businesses that are currently having trashed picked up need to be placed on notice that this will no longer be the case, with a date to be set forth by the <u>Mayor and Administration</u>.

I respectfully request your response prior to the next meeting of the City Council which is scheduled for May 25, 2021 as the item will be placed on the agenda for that meeting.







2. Discussion of proposed FY22 budgets for Water and Sewer Divisions
The Administrator of Community Utilities gave a brief overview of the Fiscal Year 2022 Budgets
for the Water and Sewer Divisions. He stated that the proposed rate increases are \$0.07 per 100
cubic feet (CCF) for sewer usage, \$0.05/CCF for water usage and \$1.00 per equivalent
residential unit (ERU) to the stormwater fee. An ERU is defined as 2,800 square feet of

impervious area. He also mentioned that one CCF is equal to 748 gallons. The Administrator of Community Utilities then stated that the combined impact of the rate increases to the average family using 109 gallons per day (53 CCF per year) is \$10.36 per year or \$0.86 per month. Council President Cliff Ponte asked the Administrator of Community Utilities what would need to be cut from the budgets, if the rate increases are not approved. The Administrator of Community Utilities stated that the first item to be cut from the budget would be the \$100,000.00 for the Stabilization Account. He then stated that capital items would need to be reviewed. He also stated that electricity and chemicals cannot be reduced. The Director of Financial Services stated that the infusion of funds from the American Rescue Plan will be used next year on infrastructure. Councilor Shawn E. Cadime stated that the use of one time funds is not a good practice, because when there are no one time funds available there could be an increase of \$.80 per CCF instead of \$.07 per CCF. He then asked when some of the significant debt will begin to decline. The Administrator of Community Utilities stated that some of the significant debt for the Combined Sewer Overflow (CSO) tunnel will begin to drop off in the next few years. He also stated that many communities are facing significant increases, due to maintaining rates with no increases for too many years. Councilor Pam Laliberte-Lebeau asked when the stormwater fee was implemented. Paul Ferland stated the stormwater fee was implemented in 2008 and it was initially \$35.00 per quarter. Councilor Michelle M. Dionne asked if Terrance Sullivan, the former Administrator of Community Utilities is still working for the City on an as needed basis. Paul Ferland stated that Mr. Sullivan is still working when needed. He then stated that due to a lack of licensed individuals at the wastewater treatment plant, he will be covering a shift tomorrow night. Councilor Trott Lee asked why \$30,000.00 was needed for postage. Paul Ferland stated that is the amount of postage necessary to mail utility bills. Councilor Trott Lee then asked Paul Ferland, if the bills could be sent out electronically. Paul Ferland stated that he did not believe so because there are still many residents that do not have email. The Director of Financial Services stated that all invoices are currently available to pay online. Councilor Leo O. Pelletier stated that the main concern with the water and sewer budget is to ensure that the City of Fall River has clean safe water. Councilor Shawn E. Cadime stated that everyone needs to understand that when loan orders are approved to make significant upgrades, then rate increases will be necessary to support those loan payments.

 Committee on Finance meet with Administration to discuss trash collection and proposal for Cart Program

On a motion made by Councilor Christopher M. Peckham and seconded by Councilor Trott Lee, it was unanimously voted to lift the matter from the table. The Director of Community Maintenance provided an updated overview of trash collection and the cart program. He then stated that there is one EZ Disposal truck collecting trash and recycling from the commercial businesses that are on the list of exceptions, in order to get an accurate weight. Councilor Michelle M. Dionne asked the Director of Community Maintenance if the 100 carts for solid waste, recycling and yard waste that were ordered are all 95 gallon. John Perry stated that all the carts in this previous order were 95 gallon carts. Councilor Pam Laliberte-Lebeau stated that there are a group of houses on Robeson Street, which total 32 units. She then stated that 32 units all purchased at the same time should constitute a business. Councilor Michelle M. Dionne asked the Director of Community Maintenance, if he feels that the City is getting close to resolving the solid waste problems. John Perry stated that he believes that the collection of commercial trash and recycling should be resolved soon. He then stated that when the market for recycling crashed, there was a loss of revenue. He also mentioned that without a revenue generating stream, such as fees or pay-as-you-throw there will always be a shortfall in solid waste collection account. The City Administrator stated that all communities are having the same problems with the costs for solid waste collection. John Perry stated that the best way to handle costs is the pay-as-youthrow program. He also stated that he would like to construct a recycling center at the Lewiston

Street facility. Councilor Michelle M. Dionne stated that she would like to see a redemption center for bottles and cans added to a recycling center. Councilor Linda M. Pereira asked how much does the City owe on trash trucks. John Perry stated that he believes that they have been paid off, but was unsure and will check on the matter. On a motion made by Councilor Bradford L. Kilby and seconded by Councilor Christopher M. Peckham, it was unanimously voted to table the matter.

2. Mayor and order appropriating \$1,809,616 from Community Preservation Act funds for Fiscal Year 2022 Community Projects

On a motion made by Councilor Bradford L. Kilby and seconded by Councilor Trott Lee, it was unanimously voted to refer the matter to full Council for action.

- 3. Presentation of Fiscal Year 2022 Municipal Budget
  Mayor Paul E. Coogan provided a brief overview of the Fiscal Year 2022 Municipal Budget. He
  stated that the City of Fall River is fortunate to have received American Rescue Plan Act (ARPA)
  funds. He then stated that unfortunately these funds came about at a terrible price,
  approximately 370 residents died due to the COVID-19 pandemic. Councilor Trott Lee asked if
  there is a tax increase included in the Fiscal Year 2022 Municipal Budget. Mayor Paul E. Coogan
  stated that a 2 ½% tax increase is included in the budget. The Director of Financial Services
  gave a detailed presentation of the Fiscal Year 2022 Municipal Budget.
- Presentation of Fiscal Year 2022 School Department Budget Superintendent of Schools provided an overview of the Fiscal Year 2022 School Department Budget. Council President Cliff Ponte asked if there was a PowerPoint presentation. The Superintendent of Schools stated that there was no presentation, but the financial team will answer any questions that the City Councilors may have. He stated that the Fiscal Year 2022. School Department Budget is 100% of Net School Spending and contains 67 new positions. Councilor Michelle M. Dionne stated that she noticed various vacant positions in the budget. Kevin Almeida stated that there are numerous retirements and some positions are difficult to fill. Councilor President Cliff Ponte stated that he finds it very confusing when reviewing the School Department Budget, as salaries listed are average salaries and not actual salaries. Councilor Bradford L. Kilby asked if the new high school will open in September of 2021. The Superintendent of Schools stated that the new high school will open in September. Kenneth C. Pacheco stated that the demolition of the old high school will begin in the fall and will continue while students are in school. He also stated that due to the COVID-19 pandemic the availability of building materials is very slow. Councilor Pam Laliberte-Lebeau asked if there is any gang prevention in the schools. The Superintendent of Schools stated that the School Department is discussing the return of gang prevention in the schools.

Kevin Almeida stated that the School Department has over 2,000 employees. He then stated that salary savings occur due to employees retiring and also leaving for other employment opportunities. Council President Cliff Ponte stated that the School Department will be receiving over \$40 million dollars from the federal government. He then asked if there are any plans for the use of these funds, such as the new high school. Councilor Leo O. Pelletier asked who paid for the repairs needed to the roof on the new high school. Kenneth C, Pacheco stated that the contractor paid for the repairs which was approximately \$1 million dollars. He also stated that there have been additional costs due to the increase in the cost of materials, but the final cost of the project will stay the same as adjustments are made to accommodate the increases. Councilor Leo O. Pelletier then asked if the upgrades to the Watson School were almost complete. Kenneth C. Pacheco stated that the Watson School is almost complete. Councilor Leo O. Pelletier then asked how many students are enrolled in Fall River Public Schools. The Superintendent of Schools stated there are 10,170 students enrolled in Fall River Public Schools. Councilor Linda M. Pereira stated that she attended the Durfee Alumni Awards Ceremony and many graduates of B.M.C. Durfee High School have been accepted to great colleges across the country.
