Upon reviewing our records we have concluded that we need to amend our CPF M 102: Campaign Finance, 8th day preceding election report for 2017. During our review we found the following errors:

\$143.44 was added to Line 12 on Schedule B. We found that this was the cost of an expenditure on a previous report that was accidentally added to Line 12. We have subtracted this amount from Line 12 on Schedule B.
