RESOLUTION 2017-18

**AUTHORIZING THE SALE OF A CITY-OWNED VEHICLE NOT NEEDED FOR A  
MUNICIPAL PURPOSE TO THE WARREN COUNTY CAREER CENTER**

WHEREAS, the City of Franklin Fire & EMS Division has a 2000 McCoy Miller Life Squad that has reached the end of its useful life and is no longer needed for a municipal purpose;

WHEREAS, the Warren County Career Center, a political unit of the State of Ohio, has need of a Squad for firefighter and emergency medical technician training; and

WHEREAS, in accordance with Section 115.03 of the Codified Ordinances of the City of Franklin, this Council may authorize the sale of City-owned personal property not needed for a municipal purpose, regardless of the property's value, to any political unit of the State of Ohio upon such terms as may be deemed proper by Council, without competitive bidding,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Franklin, Ohio, a majority of members present concurring, that:

Section 1. It is hereby determined that the following City-owned vehicle, under the management and control of the Division of Fire & EMS, is not needed for any municipal purpose: a 2000 McCoy Miller Life Squad, VIN 1FV3EFBC2YHB73130.

Section 2. The City Manager is hereby authorized to sell said vehicle for one dollar (\$1.00) to the Warren County Career Center, a governmental entity of the State of Ohio, without competitive bidding, upon such terms and conditions as are approved by the Law Director.

Section 3. It is found that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

Section 4. This Resolution shall become effective immediately upon its passage.
