RESOLUTION 2017-26

**AMENDING RESOLUTION 2016-60 AND AUTHORIZING POSITION TITLES AND
THE NUMBER OF POSITIONS FOR EACH TITLE FOR CITY OF FRANKLIN
PERSONNEL FOR THE YEAR 2017**

WHEREAS, Section 3.03 of the City of Franklin Charter grants this Council the power to fix the number of employees in the various offices, departments, divisions, bureaus, boards and commissions of the City, by ordinance or resolution;

WHEREAS, Section 145.01 of the Codified Ordinances of the City of Franklin requires this Council, by ordinance or resolution, to establish a yearly list of position titles and the number of positions that may be filled under each title for each department of the City government;

WHEREAS, this Council has previously authorized, by Resolution 2016-60, passed on December 5, 2016, the position titles and the number of positions for each title for city personnel for the year 2017; and

WHEREAS, this Council finds that said authorization needs to be amended to reflect certain changes in staffing in the Fire & EMS Division, as recommended by the City Manager and the Fire & EMS Chief,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Franklin, a majority of the members of Council present concurring, that Resolution 2016-60 is hereby amended as follows:

Section 1. The following list of position titles and the number of positions to be filled under each title for the year 2017 is hereby authorized and approved, subject to the availability of funds authorized in the Annual Appropriations Ordinance:
