WHEREAS, in accordance with the City Charter, the City's Ordinances and Ohio law, Council must appoint members to various Boards and Commissions; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Franklin, Ohio, a majority of Councilmembers present concurring, that:

Section 1. The following member of Council is hereby appointed to the City of Franklin Planning Commission for a one (1) year term, January 1, 2018, to December 31, 2018:

Section 5. The following person is hereby appointed to the Board of Zoning, Building & Housing Appeals, for a four (4) year term, January 1, 2018 to December 31, 2021:

Section 6. The following person is hereby appointed to the Civil Service Commission, for a six (6) year term, January 1, 2018 to December 31, 2023 and one appointed to fulfill the remainder of a term expiring December 31, 2021 (Mr. Edwards resigned):

Section 7. The Board and Commission members herein appointed shall serve their appointed terms and shall continue in office until their successors are appointed. In the event any member is unable to complete his or her term, the designated alternate, if any, shall serve out the remainder of the term and shall continue in office until his or her successor is appointed.

Section 8. It is found that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

Section 9. This Resolution shall become effective immediately upon its passage.
