RESOLUTION 2019-31

**APPROVING AN ADDENDUM TO THE CONTRACT WITH RUMPKE OF OHIO TO INCLUDE
AN ADDITIONAL PER MONTH COST DUE TO THE PASSAGE OF THE OHIO
TRANSPORTATION BUDGET BILL FOR THE PERIOD JULY 1, 2019 THROUGH
SEPTEMBER 30, 2020.**

WHEREAS, Section 931.04 of the Codified Ordinances of the City of Franklin, Ohio, grants Council the authority to establish, by resolution, rates for garbage collection, recycling and yard waste disposal for all residential units in the City, according to the current contract for such services;

WHEREAS, this Council, by Resolution 2014-24, adopted August 4, 2014, authorized a three-year contract with Rumpke, Inc. for the City's solid waste and commingled recyclables collection and disposal services, to run from October 1, 2014, through September 30, 2017, with three potential one-year renewals of the contract at an already agreed upon price; and

WHEREAS, the State of Ohio recently passed a new gas tax in early April 2019; and

WHEREAS, the 2019 Ohio Transportation Budget bill requires Ohio drivers to pay an additional tax of 10.5 cents per gallon of gas and 19 cents per gallon of diesel fuel, beginning July 1, 2019; and

Whereas, Rumpke is proposing to adjust our monthly unit price; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Franklin, Ohio, a majority of members elected thereto concurring, that:

Section 1. The additional fee of \$0.09 per unit per month applied to the monthly unit price is hereby approved by Council, to begin on July 1, 2019.

Section 2. It is hereby found that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

Section 3. This Resolution shall become effective immediately upon its adoption, and the changes set forth in this Resolution will be administered July 1, 2019.
