RESOLUTION 2022-57

AWARDING THE BID AND AUTHORIZING EXECUTION OF THE CONTRACT WITH CG CONSTRUCTION AND UTILITIES INC. FOR THE 2022 BRYANT AVENUE WATER MAIN REPLACEMENT PROJECT.

WHEREAS, bids for the 2022 Bryant Avenue Water Main Replacement Project were opened on July 7, 2022, in accordance with the Notice to Bidders;

WHEREAS, it is determined by Council that the bid from CG Construction and Utilities Inc. is the lowest and best; and

WHEREAS, this Council, by Ordinance 2022-10 has authorized the expenditure of funds for said contract through the appropriation of funds in the City's operating budget,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Franklin, Ohio, a majority of the members present concurring, that:

Section 1. The Bid for the 2022 Bryant Avenue Water Main Replacement Project is hereby awarded to CG Construction and Utilities, Inc., 6891 Germantown Pike, Miamisburg, Ohio 45342, in the total bid amount of One Million Seventy-Five Thousand One Hundred Forty Dollars and 00 Cents (\$1,075,140.00), all in accordance with the Notice to Bidders, Instructions to Bidders, General Conditions, Specifications, Plans, and other documents contained in the bid packet.

Section 2. The City Manager is hereby directed to execute a contract with CG Construction and Utilities, Inc., for the 2022 Bryant Avenue Water Main Replacement Project, in accordance with Notice to Bidders, Instructions to Bidders, General Conditions, Specifications, Plans, and other documents contained in the bid packet upon which the bid was received. The costs of the contract shall be paid out of the funds appropriated for it in the City's operating budget.

Section 3. It is hereby found that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

Section 4. This Resolution shall become effective immediately upon its passage.
