RESOLUTION 2023-61

ACCEPTING THE AMOUNTS AND TAX RATES AS CERTIFIED BY THE WARREN COUNTY BUDGET COMMISSION FOR 2024,
AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THE TAX LEVIES TO THE WARREN COUNTY AUDITOR

WHEREAS, in accordance with Ohio law, this Council, by Resolution 2023-38 adopted June 5, 2023, has previously adopted a tax budget for the next succeeding fiscal year commencing January 1, 2024;

WHEREAS, in accordance with Ohio Revised Code Section 5705.34, the Warren County Budget Commission has certified its action thereon to this Council, along with the County Auditor's estimate of the rate of each tax necessary to be levied by this Council, and what part thereof is without and what part within the ten-mill tax limitation; and

WHEREAS, Ohio Revised Code Section 5707.34 requires this Council to authorize the necessary tax levies and certify them to the Warren County Auditor,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Franklin, Ohio, a majority of the members present concurring, that:

Section 1. The tax amounts and tax rates, as determined by the Warren County Budget Commission in its certification, be and the same are hereby accepted.

Section 2. There be and is hereby levied on the tax duplicate of the City of Franklin the rate of each tax necessary to be levied within and without the ten-mill limitation as follows:



Section 5. This Resolution shall become effective immediately upon its passage.


