**COMMITTEE MEETING**

**1. Finance: 4:45-5:45**

Aldersperson Hawkins called the meeting to order.

Aldersperson Hawkins opened the floor to discussion on the Railroad Overpass, pointing out the pros and cons. After discussion by the council, it was determined there was no money in the budget for the 20% application fee and the cons weighed out the pros.

Motion by Aldersperson McDowell, seconded by Aldersperson Pierson to decline the submission of a grant application for the Railroad Overpass. All voted yes, motion carried.

Motion by Aldersperson Eavenson, seconded by Aldersperson Pierson to award RCS Construction, Inc the bid for the MFT Century Drive Pavement Patch Program with the low bid of \$133,125.00. All voted yes, motion carried.

IT Director Harsha Yellanki gave a brief presentation on the Audio Video Project outlining the need for the upgrade of the Council Chambers. There were four bids submitted. The recommendation was to contract with KCAV with a bid of \$111,930.38. Harsha stated KCAV was not the lowest bid, but of the four, the ratio of the cost of equipment vs labor gave the city more equipment and was the best fit for the needs of the project. Harsha added that the upgrades would allow the meetings to be viewed on multiple platforms.

Motion by Aldersperson Hawkins, seconded by Aldersperson McDowell to award the bid to contract Audio Video upgrades to KCAV in the amount of \$111,930.38. All voted yes, motion carried.
