Aldersperson McDowell stated the proposed Ordinance would update the current Municipal Code to allow for LED signs.

Building & Zoning Administrator Greg Koberna stated signs could vary in size not to exceed 16 sq. feet. Alderperson Eavenson stated most are monument style with timers to dim the lights.

In the absence of Alderperson Harrington, Alderperson Hawkins called the meeting to order.

Alderperson Hawkins deferred to Assistant Police Chief Major Bremer.

Bremer stated the department had received complaints about the intersection of Maryville Road and Pontoon Road about speeding and traffic accidents. He stated the average was one accident a month, noting in the past six months there had been nine accidents, one being a fatality.

Mayor Parkinson stated the number of crashes a year had gone down from fourteen to two at the intersection of 17th St and Madison Ave since the red light camera was installed. Adding this is not a money grab, because of the penalty, people will stop. This is about protecting the citizens.

Alderperson McDowell and Alderperson Pierson are in favor and have seen the impact the current red-light camera has made in Ward 3.

Alderperson Smith inquired about the cost of adding cameras.

Lieutenant Roberts stated there would be an extension of the current contract. He stated the company had agreed two cameras on Maryville Road were a good idea. They are currently doing an investigation to determine if two additional cameras could be placed to cover the intersection all four ways.

Roberts stated a full proposal would be brought back to the council.

Alderperson Davis called the meeting to order.

Alderperson Davis deferred to Ray Warren, General Manager of The Mill Event Center.

Warren gave a presentation on the proposal for a Granite City Jam Musical Festival to be held on August 23, 2025. Phil Callis would like to partner with the City in creating the event with the hope of it becoming an annual event. Callis has contracted four music acts and will cover the entire cost of the acts, act riders, staging & production, chair rental and kids' activities in the amount of \$37,500.00. The estimated cost to the city for Street Department, Security, portable toilets and trash receptacles is \$15,090.00. There are currently two sponsors at \$1,000.00 each to offset the cost to the city, with more sponsorship being sought after.

Alderperson Davis clarified the event would be held outside and stated that in the future, proposals should be presented to and approved by the Council before any posts or advertising goes out to the public. She added she did not think kids' activities were needed for this type of event.

Mayor Parkinson agreed mistakes had been made, adding he did not see the need for the kids' activities either. He stated the fact that Callis had already contracted the acts was not the city's concern, if voted down Mr. Callis had other options.

Alderperson Pickerell asked Major Bremer if he felt the Police Department could handle this type of event. Major Bremer stated the Police Department plans security for similar events for the Fourth of July and Mardi Gras, adding there is a plan in place with mutual aid from surrounding departments as a back-up if needed. Major Brooks was confident that the Police Department could cover the event.

Alderperson Hawkins questioned who would carry the insurance, who would distribute VIP tickets and agreed kids' activities were not necessary, adding that if eliminated, could the \$5,000 be reallocated to offset costs to the city?

Warren stated the details were still being negotiated with Mr. Callis and the concerns of the Council would be addressed.

Alderperson Eavenson thanked Warren for the presentation, and asked if The Mill bar would be open during the event, and if there was a back-up plan in case of rain.

Warren stated The Mill bar would be open, and the event would be held because of rain and canceled in the case of hazardous weather.

Mayor Parkinson stated The Mill will not be used in the event of a rain out, the space is not large enough.

Alderson Smith asked if the Truck Route would be blocked. Mayor Parkinson stated it would not.

Alderson Pierson questioned if moving the time of the kids' activities instead of canceling them would be a better option since they were advertised.

Mayor Parkinson stated the promo was not up long enough.

Citizen Francis Moran stated kids are part of the community and cutting out the activities would be a disservice. She stated many Granite City residents expose their children to rock and roll music all the time. She volunteered her time to help man a kids' activity tent.

The consensus of the Council is to move forward with the event.

Alderson Pierson stated the Route 66 Sock Hop was extremely hot and dusty and packed at 11:00 a.m. She said that the time spent with the Travel Writers at Jerry's and the Speakeasy was enlightening to hear people from around the world are flocking to the Midwest.

Mayor Parkinson stated Clerk DeYong will work with the Legal Department and bring it back to the Council.
