Aldersperson Smith called the meeting to order.

Aldersperson Smith opened the discussion of a Granite City Phone App for residents to report issues within the city. The App would allow residents to ping the location of the problem (street issues, code violations, animal control, etc.), upload a photo and direct the information to the City.

City Clerk Jenna DeYong stated the App would run through her office with links to services within the City (Republic Trash, American Water, etc.), adding it would have a link to pay City bills through E-Gov and residents would have the ability to report problems after hours without having to call the City.

Aldersperson Hawkins questioned if the App would be for registered users only, adding he feared anonymous users could abuse it.

Clerk DeYong stated the City would set up the information that is accepted, and the App would mirror the website.

Aldersperson Harrington asked what the cost of the App would be.

Clerk DeYong stated it would be in the Clerks' budget and cost \$2,000 to set up and \$2,000 a year to maintain.

Motion by Aldersperson Smith, seconded by Aldersperson Davis to move forward with the purchase and maintenance of the App. All voted yes; the motion carried.

Aldersonperson Hawkins stated that on November 6, 2012, the citizens approved a referendum that mandates the city to provide an electrical aggregate. He stated he wanted it known that the current Administration and Council had no choice in the matter.

Aldersonperson Davis added that Granite City was not the only city on the ballot, the ballot was universal County wide.

Mayor Parkinson stated his office is inundated with complaints that are out of his control, adding he would like the program to be OPT in not out of.

Motion by Aldersonperson Hawkins, seconded by Aldersonperson Pierson to approve a Resolution authorizing the execution of a service agreement for the supply of electricity for residential and small commercial retail customers who do not opt out of such a program. All voted yes; the motion carried.

Aldersonperson Harrington deferred to Chief Brooks.

Chief Brooks advised of the intent to use a mixture of Federal and State Drug Asset Forfeiture Funds to purchase an armored vehicle. He stated Madison County and Alton both have one that can be requested for use but often is not available, adding that if available, it takes anywhere from 30 to 40 minutes minimum to get the armored vehicle. If the city owned it, the response time would be 5 to 10 minutes. Chief Brooks stated the vehicle would cost approximately \$315,000.00, and would take 18 months to build, adding that it is important to know these funds cannot be used for road repairs, squad car replacement etc. They are earmarked for specific police use.

Mayor Parkinson inquired if Chief Brooks had confirmed that the vehicle would meet the criteria to use the funds. Chief Brooks stated he had.

Aldersperson Hawkins stated a price cannot be put on the lives of the City's Officers, adding that criminals need to be aware the city is serious about crime.

Motion by Aldersperson Hawkins, seconded by Aldersperson Smith to approve the purchase of an armored vehicle. All voted yes; the motion carried.

Chief Brooks advised that due to retirement and resignations there are three vacancies to be filled.
