**23-043:** Councilmember Devey made a motion to create and fund the positions needed to operate the in-house sanitation services including a Sanitation Supervisor position, as described in the job description, with a starting salary of \$50,000.00 per year, and two Sanitation Laborer positions, as described in the job description, with a starting salary of \$16.00 per hour; positions are to be funded by the Sanitation Enterprise Fund, with an initial transfer from Cash Reserves. Councilmember Battle seconded the motion.
