



Although it is not required, you may obtain an attorney, at your own expense, to represent you at the hearing.

If you fail to appear at the time and place of the hearing, you shall be deemed to have waived the right to a hearing to contest the citation, and the determination a violation was committed shall be final. In this event, the Code of Ordinance Enforcement Board shall enter a final order determining that the violation was committed and may impose a civil fine up to the maximum set forth in the citation.
