**MEMBER FACILITY AGE GUIDELINES (GUESTS MUST BE 14 TO USE FACILITY)**

The following guidelines apply to all youth not participating in supervised, structured program while in the facility.

**Age 11 years and under**—Age 11 and under are allowed in gym, racquetball court, track, cardio area and group exercise room *with direct supervision*. Youth 11 and under are not allowed in weight room.

**Age 12 years to 15 years**— Permitted access to entire facility *without a legal guardian when a signed Youth Waiver and Youth Code of Conduct is on file.*

**Age 16 years and older**—Unlimited access to entire facility.

**\*\* A limit of 6 youth may be in Weight Room/Group Exercise Room at once.**

**Youth Waiver (12 years to 15 years)**

Huxley Parks and Recreation 3 C’s Fitness reserves the right to review any inappropriate behavior and conduct and deny access or membership to any member or guest at the discretion of Huxley Parks and Recreation staff. I understand that my child \_\_\_\_\_ will be held accountable in instances of inappropriate behavior in the following way. 1) Verbal warning by HPR Staff, 2) Notification to parent, 3) Asked to leave 3 C’s premises. I agree that should any inappropriate act deem that my child leave the premises immediately, the above process will not apply. I also understand that as a consequence my child’s and/or my membership may be terminated. I further understand that HPR management has the authority to amend policies and procedures at any time to ensure the delivery of the highest services to the general membership.

I understand the HPR 3 C’s activities have inherent risks and in consideration for membership and participation in programs I hereby assume all risks and hazards incident to my participation, due to negligence of HPR or otherwise while in, about, or upon the premises of HPR and/or while using the premises or facilities or equipment thereon or participating in any program affiliated with HPR. I further waive, release, absolve, indemnify, and agree to hold harmless HPR, the organizers, volunteers, supervisors, officers, directors, participants, coaches and referees from any claims or injury sustained during my use of the HPR property or participation in programs. I expressly assume all danger, risks, and hazards to me and all minors in my care.
